NSW CLASSIC VEHICLE REGISTRATION CHECKLIST March 2023

NEW REGISTRATIONS

Member's vehicles over 30 years of age may be registered through the Club according to the rules of the Club and the Policy of Transport for NSW. If vehicles are modified, they may be required to be registered under the Classic Vehicle Scheme. A Club representative makes determinations on eligibility for Historic or Classic registration.

Classic Vehicle registration is administered by the NSW HMC. The NSW HMC have issued a comprehensive document with detailed instructions and links to forms. The NSW HMC is our peak motoring body.

The Classic Vehicle Declaration is to be stamped by an Authorised Official to confirm membership .. In 2021 the Authorised Officials are David Schmidt, ph.0427200035 or David West ph. 0407958504.

For new registrations an Application for Conditional Registration is also required.

GVM on 1835 forms

The box must be completed since the RMS/ServiceNSW Counter staff are instructed to ensure that the vehicle GVM is under the 3.5 tonne maximum eligible for the CVS.

Owners are to be “empowered” to find the information themselves. This might be achieved by examining plates attached to the vehicle, old registration documents, blue slip, or on-line sources such as automobile-catalogue.com or carfolio.com. See examples below.

Commercial vehicles, some utes and some 4WD vehicles are likely to have GVM values available. Light passenger sedans, coupes, etc usually do not. However it is always worth checking on line because **some historic cars do have a GVM specified**. Check out these links which give a GVWR figure for a Jaguar Mark 2 (3.8) of 1890kg. and for a 1984 Range Rover. I have also checked a 1982 MB 500 SEC today and it had a GVM showing on its IOD plate.

GVWR (gross vehicle weight rating) is the same as GVM (gross vehicle mass).

Tare or Kerb weight is not GVM and cannot be used in this box.

CVS Inspection Certificates

As you know we ask that owners sending their applications to ACMC provide copies of their blue slips, pink slips and engineering. Not the originals.

- The Blue Slips must include the completed design and identity check.
- The HMA CVS office needs to be able to read the complete Pink Slip and Blue Slip. So please re-attach the Brake Test slip so it does not obscure information on the Pink and Blue Slips, or copy the brake test and include it with the other documents.
- CVS registration payment to the HMA office. Whilst EFT is the preferred means, the HMA CVS office now accepts payment by credit card. There are two options: 1. Complete the credit card form and include it with documents, or 2. Indicate with the documents that you wish to pay by credit card and the HMA CVS Office will call for credit card details when processing the registration.
