## What happens to the information you provide?

The information you provide will be provided to MailChimp, where the <u>Privacy for Contacts</u> is applicable to all our BV News subscribers.

MailChimp collects and holds the information and makes it available to Badminton Victoria (BV). This information is collected so BV may use MailChimp's services. MailChimp's <u>Terms of Use</u> enables websites to sign up website visitors, collect and retrieve visitor sign-up data, and to develop and execute email communications with visitors and others (including your customers).

BV will use the information you provide to send relevant emails. By signing up to the BV News email subscription service, you also agree to receive emails promoting services and products of Badminton Victoria's official partners.

# If you want to know what personal information is held

If BV refuses to correct the personal information as requested, the BV must provide a written notice that sets out:

- the reasons for the refusal, except to the extent that it would be unreasonable to do so
- the options available to complain about the refusal.
