An update from our Committee Meeting – 5th August 2020

COVID-19

The current Covid situation was discussed and this statement from our Covid-19 Safety Officer supported by the Committee:

"On Friday 31 July, the ACT Government advised ACT residents to avoid all non-essential travel to NSW, and correspondingly discouraged all non-essential visitors to the ACT from NSW (outside of the Capital Region) as a result of this advice, BMRC has decided not to host any visitors from outside the ACT region whilst this advice remains current. Unfortunately, this impacts events such as the upcoming WTTs.

The current ACT Government advice is clear for gatherings in communal areas in the club. During the current Covid conditions, the Committee has decided to not allow any gatherings in the shed.

You may have seen the new lightweight quad, and a few of us have had a row. My description after a short paddle - very smooooth. Thanks to Alex and Susan who drove to and from Yass to collect it. Thanks to Alex, Darrell and Cecilie for setting up the boat initially and adjusting the oars.

We will have a boat-naming ceremony for this quad and other recent additions to our fleet when the weather warms up and Covid restrictions allow!

We have also acquired a new trolley – part of our solution to lack of racking space for our substantial fleet.

Annual boat safety audit

Club safety audits are carried out regularly by the Club Safety Officer and/or Club Captain, Vice Captain. Over the last, and next few weeks, we are conducting the annual boat safety audit. This not only ensures that any weakness in our equipment are identified and rectified, but that our equipment also complies with criteria set out in Rowing Australia's Rules of Racing. The audit is being undertaken using the Quick Reference Checklist at right (not to scale), based on the BMRC Safety Manual. A scaled version is attached to this newsletter.

We will be using the next WTT as an opportunity to check boats that have not yet been assessed, in particular, the big boats. The checks only take a couple of minutes, and we will make sure not to get in the way of boating and racing.

But what can you do?

In addition to the formal audit, we strongly encourage all rowers to check that their boat (whether a Club or private boat) complies before going out onto the water and take remedial action as appropriate. If any of these requirements cannot be met, please notify the Club Captain, Vice Captain and/or Safety Officer.

Reminder about cold mornings



BOAT SAFETY ASSESSMENT QUICK REFERENCE CHECKLIST

Safety audits of club boats, following the below checklist, are regularly carried out by the Safety Officer and/or Club Captain to ensure compliance with Rowing Australia's Rules of Racing. However, rowers are also encouraged to check their boat before going out onto the water. If any of the below are not met, please notify the Club Captain, Vice Captain and/or Safety Officer.

Item	Minimum standard required
Bow balls:	A while solid bow ball is firmly affixed, with a minimum
	diameter of 4 cm.
Quick release:	Each shoe device is independently restrained such that
	the heel will not lift more than 7 cm from where it is tied
	down. Laces, Velcro or similar materials must be able to
	be released immediately with a single quick hand action
	of pulling on one easily accessible strap.
Buoyancy	Boats are appropriately sealed/fitted with bungs and the
compartments:	interior of the boat is watertight.
Steering:	Rudder lines, steering mechanisms, the rudder and fin,
	are secured and in good working order.
Coxswain's seat:	The opening of the coxswain's seat must be at least 70
	cm long and it must be as wide as the boat for at least 50
	cm. The inner surface of the enclosed part must be
	smooth and no structure of any sort may restrict the
	inner width of the coxswains section.
Blades:	3 mm from the outer edge of the blade for oars, must
	have a minimum thickness of 5 mm throughout, and 2
	mm from the outer edge of the blade for sculls, must
	have a minimum thickness of 3 mm throughout.
