A Guide for Nominations for the Awarding of Life Membership

The **Centenary Rowing Club (CRC) Incorporated** Rules defines types of membership. Life Membership is but one of them. However, Life Membership is the most prestigious award available to the Club and as such the nomination and award should be given careful consideration.

Life Membership

Life Membership is a special form of membership which may be bestowed upon any person whose services to CRC is agreed to have been sufficiently meritorious. Nominations for Life Membership, together with an appropriate support statement specifically detailing the nominee's involvement within the CRC, and contributions to it, must be submitted in writing to the Centenary Rowing Club Committee at least 7 days prior to the CRC Annual General Meeting. Any nomination must proposed by a voting member and seconded by another voting member.

Nomination

The nomination must be made on the pro forma included with this guide. All relevant sections must be completed and no other form of nomination shall be acceptable. This nomination will form the basis for the appointing of Life Membership as determined from time to time.

Centenary RC Process

Nominations for this award should be sent to the CRC Management Committee. The Committee shall consider the merit of the application against the criteria and make its recommendation, which in turn may recommend that the Annual Meeting endorse the appointment and award the Life Membership.

Guide to Nomination Criteria

Life membership may be recommended for any highly meritorious contribution to the sport. The following do not attempt to be exhaustive guidelines, but rather to give ideas and scope to the types of contribution that could be rewarded.

- Athlete or Coach in an Australian rowing team at an elite level over a number of years including Olympic representation.
- 2. Administration, either paid or in a voluntary capacity to CRC or its affiliates
- 3. Club Official
- 4. Club coach
- Other work associated with the development and promotion of the Centenary
 Rowing Club

These contributions may be supplemented by contribution to the sport of rowing beyond the immediate CRC environment, which might include:

- 1. Regional, Sate, National or International Rowing Association
- 2. Regional, State or National Performance Centre
- 3. Other relevant Organisation e.g., Secondary Schools
- 4. Contributing club or schools with active rowing programmes

Notwithstanding all the above, the following will be deemed highly desirable attributes for this level of membership:

- 1. Active contribution to the wider CRC rowing community in various roles
- Providing meritorious contribution and distinguished and conspicuous service (including contributions in a leadership role) to CRC and the wider rowing community.

Consideration of service solely as an athlete will be deemed insufficient.

Intermittent contribution by a nominee over several periods of time will be taken into account.

All details of the history of contribution should be included on the following nomination document.
