- 6. **NT Junior Representatives DTTA Financial Support GG** The DTTA 2019 Junior Representatives are:
 - Mitch Bedford, Dae Gerschwitz, Zakelli Xie, Martin Feng, Renee Li and Sebastian Lai (6 players). Decision D190401 was that the DTTA club would support juniors with \$300 each and additional funding to be calculated after the Italian Festival Fundraising event. The Italian Festival (IF) is now complete and \$2,000 has been received. The IF is run biennially with previous Committee agreement (D190102) determining that the funding would be split between supporting 2019 and 2020 juniors attending the Nationals. It is proposed that each Junior receive the already agreed \$300 plus \$166 (total \$466 each. \$1,000/6 = \$166).
- 7. NT Open GG The NT Open is on Sunday 9 June 2019 (Mon is a PH) in Alice Springs. The Committee agreed (190402) that it would fund up to 1 x 12 seater van and fuel to attend the NT Open by DTTA members if there was sufficient interest. GG sought expression of interest and car hire availability. 1 x 8 seater van has been secured. DTTA members travelling are: Zakelli Xie, Dae Gerschwitz, Martin Feng, Renee & Phoenix Li, Gavin Gerschwitz, TY Lee and Elfrida Kalich. GG seeking reimbursement for van hire fee of \$515.06 plus an initial \$500 fuel allowance (in advance) (total: \$1,015) sought (with fuel receipts to be produced at following meeting to settle any balance). Per head this equates to \$126.88 each. Gavin Bedford and Mitch Bedford had already made personal arrangements to travel. It is proposed that either \$254 be approved for Bedfords (to offset costs) now, or alternatively, once total cost per head is finalised (following return of fuel receipts) that the per head payment is provided to 2 x Bedfords.

- 6) NT Representatives Junior Nationals Discussion ensued re the DTTA selections for NT Representatives at the Junior Nationals and Coach TY. It was recognised that with the number of children selected it will be impossible for TY to provide coaching assistance to all children with games being played concurrently. The Committee requested that GB and GG (who are attending event) offer support during the games that TY cannot be at. **DECISION (D190401)** The Committee agreed to fund each selected/attending DTTA junior \$300 with further funding to be considered following the Italian Festival Fundraiser event.
- 7) NT Open (GG) is now confirmed for Sunday 9 June 2019 in Alice Springs. The Committee agreed that DTTA membership should be emailed to seek interest of members in attending the NT Open and if sufficient interest existed, Committee agreed to provide funding for a 12 seater van (including fuel) to attend for participants (**D190402**). There also exists the

possibility to explore billeted accommodation within Alice Springs. GG to draft and send communication.

CD to prepare 'adverts' for newsletter seeking Committee nomination for specific roles (eg IT, Supply Purchaser, Volunteer Coordinator). GB and MY to coordinate BBQ arrangements (anticipate expenditure around \$200, although try and arrange main supplies on the morning once we understand attendance. CD to devise games / competition. DECISION (D190403) Committee agreed that \$200 prize money for competition to be made available with categories provided for different grades. RH to promote through Newsletter.
- 9) Honorarium for Auditor Paper distributed by CD. **DECISION (D190404)** Committee approved the proposal to fund \$250 of Bunnings vouchers for Auditor Iain McPherson.
- **10) Events: Arafura** Committee recognised the great effort of Mitch Bedford and Max Duffel in their matches. Committee further noted the great work of DTTA members who stepped up and contributed to the operation of the Arafura Games especially the pack up day on Saturday 4 May.
