#### NOTICE OF SPECIAL RESOLUTION

Notice is hereby given pursuant to section 249L (1) of the *Corporations Act 2001*, that at the upcoming AGM, it is intended that the following motion be proposed as a **special resolution**:

THAT the current Constitution of the Esperance Hockey Association be repealed and the proposed new Constitution attached to the notice of the meeting of the members of the EHA, be adopted as the Constitution of the EHA.

By way of summary, the executive committee is proposing to amend the EHA Constitution in order to:

- Change the financial year of the association from calendar year to 1<sup>st</sup> November 31<sup>st</sup>
   October each year
- Amend the wording of affiliated club to affiliated team and amend the description of how the affiliated team is a member of the association
- The recommending and appointing of life membership has been changed
- The role of the team delegate has been defined
- Defined a casual player membership
- Quorum for special general meetings has been changed from 1/3 of the member base to
   13 financial members
- The term 'management committee' has been changed to 'executive committee' throughout the document
- How members vote at a meeting has been included
- Defined the committee ability to pass a resolution outside of a committee meeting
- Defined the number of committee meetings that must be held in one financial year
- Wording changed from 'powers of the association' to 'powers of the committee'
- Personal interest of committee members has been included
- Sub committee's role and responsibility has been updated
- Inclusion clause of the Liquor Act and the club's role and responsibilities
- Removal of the By-laws clause

Ian O'Dea and Henry Johnston the two Vice Presidents – thank you for your assistance and advice throughout the year. It is very comforting whilst in a new role to know that someone (in this case two someones) completely have your back and the best interests of the Association at heart.

Finally Rachel and Justine McDonald – our Treasurer and Secretary. Both of these ladies have done truckloads of work this season and both have stepped down from the committee for season 2022. Thank you Rach and Juss for everything you have done for the EHA – I'm sure we will see you both back on the committee in future seasons to come and look forward to seeing you both out on the field in the coming weeks.

As we embark on season 2022, I'm excited to see some new faces on our committee and looking forward to working together to continue to make the Esperance Hockey Association as family friendly, welcoming, inclusive and fun as it always has been.

## ESPERANCE HOCKEY ASSOCIATION AUDITOR'S REPORT

I have examined the accounts and records of the Esperance Hockey Association for the year ended 31<sup>st</sup> December 2021 and have attached the Profit and Loss and Balance Sheet to this report.

I believe that the Statements accurately reflect the financial position of the Esperance Hockey Association as at the 31<sup>st</sup> December 2021. I have not performed any review of the Equipment or Building costs listed in the Balance Sheet and these assets have been brought forward at the values declared in the previous year. No provision has been made for depreciation. The Association may wish to undertake a review of these assets to ensure their values are still current.

During 2021 further upgrades were made to the kitchen at a cost of \$16,533.73. This expenditure is included as an asset in the Balance Sheet and is not represented in the Profit and Loss Statement.

A donation of \$1,000 was recorded during the year, as yet this money has not been received and is included in Accounts Receivable. The Committee may wish to review whether this donation is still current.

The Association had a very positive income stream for the year. Some of the expenditure to match this income has not yet been incurred; however, the Association has healthy bank balances to facilitate the associated expenditure in 2022 and beyond as these projects come to fruition. These projects include:

- Healthway's grant of \$3,994 (of which \$1,730.70 has been expended on the purchase and installation of a water fountain).
- Southern Sports sponsorship of \$3,685.50 for lights.
- Insurance Claim of \$7,156 for the outside roller door.
- Goal Post Signage Sponsorship of \$3,400 (this income has been transferred to the Reserve Account).

I would like to congratulate the Treasurer for the meticulous manner in which the accounts were presented for audit. Monthly bank reconciliations were prepared for all three accounts with all expenditure and income supported by relevant documentation and clear explanations.

I wish the Esperance Hockey Association a successful 2022 season.
