- Noted that ECTM have generously increased their sponsorship from \$750 to \$1000.
- The kitchen flooring of \$2000 has not yet been invoiced
- Norm's Cabinets donated the kitchen cupboard doors since it took so long for him to put them on

Women's Report

- There has been a lot of correspondence in the lead up to getting the season started.
- The team delegate meeting went well with the majority of ladies providing positive responses. There were 2 teams that wanted to combine specifically with each other but once discussions were had regarding their lack of umpires and strength to be competitive they agreed that the best outcome would be to split all women interested in playing evenly across 4 teams. The ladies' captains agreed to support and help recruit players for Bacchus, Strikers and Legs regroup in 2021.
- Naming each of the 4 teams after a life member – Anderson, Reid, Campbell and Mather and having an end of season award 'The Love of Hockey Award' also named after a life member – Walsh, Holthouse, Roe and Bratten was very well received by all delegates at the meeting. Life members have been contacted and were thrilled with the representation. Contact information is needed for Marg Gray and Marg Walsh. Many of them would be thrilled to present the awards at our windup.
- The fixtures have been completed with duties spread evenly
- Discussion was had regarding junior boys playing in the women's competition. Stew is going to get this information from Hockey WA
- The beginner sessions went really well. 11 ladies have been attending who have never played before but will be keen to start next season. There is one on the following Monday 20th July where Stew will be attending to run through some rules with them.
- Tash has completed the training schedule except for 1 team. Once this is confirmed she will email it through to us.
- The complaints process was discussed with JP explaining that any complaint should be tiered down through the association, not straight to the ladies' captain. The team delegate submits the complaint on behalf of the team / player to the secretary who then follows procedure as outlined in the constitution / by-laws. There seems to be some communication breakdowns amongst teams so it was decided to ask all teams for 2 delegates who can be relied upon to pass required information on to team members. Tash will send out a request to the 4 women's teams with Justine sending to the men's teams and 2019 women's teams (to keep everyone in the loop).

Men's Report

- Going well, only 3 cards issued so far for minor offences
- Castletown playing un-registered players was discussed. Fraser said that although they didn't pay until the Tuesday after their game, they were financial before the next fixture so we decided they would not be penalised but receive a warning.

Junior Report

- Toni Cronk will confirm her Narrogin visit and then contact Stew with a date for an Esperance visit
- Discussion and list of names for a high school countryweek team. The team to include girls living in Perth. Ang and Jen to liaise with Rachel and Tash re list, coach and which division to nominate them in

Umpire Report

- Stew will be attending the beginner ladies' session on Monday 20th July to run through some basic rules with them. He will be holding a junior umpiring briefing on Tuesday 21st July which has been opened up to all junior players, parents, coaches and team managers.
- Stew went through sponsors he has secured for the umpiring program he is coordinating. MLP Civil, Ian & Katherine O'Dea and Livin for Hockey have all paid. As mentioned above ECTM have increased their sponsorship amount. Jamie at ECTM has told Stew that if we would like his help around the club in any capacity he is more than willing to come down. It was also noted that if anyone from the association needs work done at ECTM they should mention they are a member of the association.
- Livin For Hockey have provided merchandise that Stew will be able to give away to his umpires.
- He has been in contact with numerous FIH accredited umpires from other states around Australia who has expressed their interest in umpiring our finals. He will continue to liaise with them if that's an avenue we want to pursue.
- Adam Kearns, an Olympic grade umpire will be coming to Esperance and would love to umpire a game.
- Stew asked the committee what area he would be allocated for the umpire program sponsor signage and where can it go.
- Some of our under 17's players are not wearing shin pads / mouthguards at games and training. It was reiterated that our junior committee endorse the following: **To ensure safety, ALL grades including minkey MUST wear shin pads and mouth guards at games and training.** Stew asked Jen if grade coordinators could follow this through with coaches and umpires every week. It was also discussed that the rule applies to juniors playing in the senior competition.
- Stew discussed the conditions of the lines. The 5-yard arc and short corner push out marks are very light. He finds it hard to teach new umpires when they can't see the lines. JP gave him Matt Ryan's number and Stew will contact Matt directly.
- Stew provided further information regarding junior male goalies playing in the women's competition but he will confirm with Hockey WA next week. It looks like a boy under the age of 15 can play in the women's competition. All juniors must have turned 12 by the 1st January in the year of competition.
- WWCC are coming through. It was confirmed that if you are coaching a team that has your child in that team you fall under the exemption rule (unless going away on an overnight camp).
- Umpires who hold up to the Community level can be assessed at countryweek if they want. There 3 regional umpires who can assess up to level 1. These are Rodney Thornton, Rodney Johnson and Stew McKenzie. Umpires wanting to be level 1 assessed can do the theory and 1 practical in their own town and then do a 2nd practical at countryweek.
- Stew would like to hold another senior briefing in a month which keeps the information fresh and provides updates as required. He urged all umpires to attend especially the senior men as some umpires do not keep up to date with current rules and they aren't calling infringements because they don't want to.
- Stew noted that he has been umpiring an under 17's game every week and said the standard of play has been good.
- We discussed the purchase of headsets again. Stew said he had submitted a grant to the Shire but had not received anything back. Rachel Hoey would chase this up with Shane Tobin. Ideally it would be good to have 3 operational sets so while we wait for the Shire Stew asked if we could purchase 1 set.

Jon Paul Adams moved a motion for the association to approve for Stew McKenzie to purchase 1 set of headsets which comprises of 3 units. The cost is estimated at \$1250. 2nd Stew McKenzie.

Motion carried: 9 votes for / 0 votes against.

General Business:

- Jon Paul Adams moved a motion to carry over Julie Waters association registration amount of \$37.00 to the 2021 season. The funds can contribute to any family members' 2021 registration fee. Ang Jeitz second.

Motion carried: 9 votes for / 0 votes against.

- Revised By-laws

The by-laws had been circulated amongst the executive committee and the following amendments were proposed:

- Remove section 3.1(b) – as it is not relevant to our structure
- Reword section 6.1 to read – 'All cards will be written on the back of the game card by the umpire. Breaches of conduct and misconduct that result in a red card will be detailed on an incident report form which the umpire will complete.
- Insert a clause on association property. This will become section 10

Stew McKenzie moved a motion to amend the above sections of the by-laws, 2nd Ian O'Dea.

Reasons for the motion:

- To protect the executive committee and provide clarity of information to our members
- Making the changes will benefit the association

Motion carried: 9 votes for / 0 votes against.

Passing of the by-laws is made by a majority vote of our current senior teams; comprising of 5 men (Cascade, Castletown, Condingup, Sharks and Rams) and 4 women's (Reid, Anderson, Mather and Campbell) for the 2020 season.

- Asset register

We don't currently have a current asset register, but it was noted that one needs to be maintained. Jen will supply a list of junior equipment and Justine will collate a general association inventory.

- 2020 Club Structure

Jon Paul Adams moved a motion that due to COVID-19 and the impacts it has had on the association all women's clubs and Wolves membership will be suspended for the 2020 season. He would also like to endorse that the 4 women's teams developed to suit a format which will enable a women's competition to be played be accepted. 2nd Stew McKenzie

Motion carried: 9 votes for / 0 votes against.

- Jon Paul Adams moved a motion that the junior committee be allowed to record and maintain their own equipment in a register and all deposits for coaching equipment will be waived for the 2020 season. 2nd Ang Jeitz.

Reasons for the motion:

- Junior committee feel its unfair to charge coaches a deposit on equipment when they are already volunteering their time. Deposits may deter future coaches
- The junior coordinator is willing to prepare an amnesty of equipment at the end of the season to limit the amount of lost property

Reasons against the motion:

- No accountability, therefore, a register must be kept and followed up
- Cost of equipment will need to be spread across registration fees

Motion carried: 7 votes for / 2 votes against.

- Kitchen Update

Esperance Plumbing have been approved to install the hand washing sink. Brown Sugar have recently closed and are selling their commercial range hood for approx. \$1000. A new one will be in excess of \$5000. JP has extended the clubs interest to purchase from Brown Sugar. He will be talking to Ken regarding installation as well as obtaining a 2nd quote from Corry Johnson Work will hopefully be scheduled for next week. The ceiling needs painting and then the kitchen should be usable.

- Countryweek

Mens – Dave Green has been obtaining expressions of interest to fill a highschool team. So far he has 6 names but will keep working on it. He would like the boys to stay at a separate accommodation to the other 2 teams. Fraser will keep in touch with Dave for updates. Fraser also said they should be able to get 2 men's teams.

Women's – discussed above in the Women's report.

Umpires – teams need to decide whether to provide their own or they have the option of each chipping in \$50 per player which will cover the cost of paying Hockey WA to supply umpires.

- Team Fees

There are currently 92 registered senior players. Hockey WA fees will come in at around \$14000 so with 9 teams this will equate to \$1555 per team. Due to COVID-19 and not being able to play a full season it was discussed to reduce the cost to teams for the 2020 season.

Ang Jeitz moved a motion that the association would set the 2020 senior men's team fees at \$1000. The women's teams will offer their players the choice of paying \$80 up front or \$10 per game. 2nd Rachel Hoey.
Motion carried: 9 votes for / 0 votes against.

- Sponsorship

JP and Rachel have been discussing sponsorship. It was decided that they would offer all current sponsors of our goals the opportunity of an additional 3-year package at \$100 per year. JP also talked about his idea of placing sponsor signs along the railings of the clubroom. These will also be offered first to our current sponsors at \$500 per year for 3 years. They will be required to pay for the cost of their own sign. Rachel will contact Topsigns for details.

- Executive Committee Member Resignation

Due to personal reasons Angela Jeitz's resigned as secretary of the association.

Jon Paul Adams moved a motion and nominated Justine McDonald to take on the role of secretary with Angela Jeitz taking over as Vice President. 2nd Rachel McDonald.

Motion carried: 9 votes for / 0 votes against.

General discussions:

- The recycling bus is coming to Esperance on 1st September offering 10cents per stubby. Is this something the association would be interested in? All agreed yes, JP will follow up.
- Fraser thanked Ian for supplying a tv to the clubrooms until we purchase one.
- Offering EFTPOS at the bar is working well with sales up.
- Primaries have a tv they are willing to donate to us which will replace the broken one in the bar. Fraser will arrange pick-up and delivery.
- It was noted that with softball no longer operational Hockey have taken on full lease of the pavilion.
- Stew mentioned that he has a national branch meeting next Wednesday 22nd July with Peter Rundle, Colin de Grussa and Martin Aldridge where he will be asking for sponsorship.

Planned clinics – umpiring and goalkeeping

1. Toni Cronk possibly coming to Esperance

Stewart McKenzie and Junior Committee are looking into a visit from Toni Cronk to run a Goalkeeper development clinic. So far Stew and Toni have discussed the following:

Toni would come down for the weekend so she can watch a few games juniors and seniors. We would look at a junior clinic on the Sunday say 8-10 am and then a senior clinic 11-1:00 then do a coach the coaches session 2-3:30-4:00.

Pricing is a little up in the air as it will be dictated by attending numbers.

Toni will come back to me this week with a few dates.

Stew has offered to provide accommodation and subsidise fuel.

2. Association Junior Goalkeeping clinics

Stew has offered to run these clinics on Sunday mornings for 4 weeks (after which time – we will review). First one is this coming Sunday (19th July 2020)

3. Umpire briefing

Stew McKenzie will be running this next Tuesday 21st July 2020. An event has been created on our Facebook page (thanks Tash) and I have asked Junior Grade Coordinators to email information out to team managers (who will then forward to all players).

4. Potentially sending an U17 boy team to Country week

Greenie is looking into putting an U17 team together to attend country week. Only 6 names so far but only put it out there this week. Greenie has approached high school re: borrowing uniforms if needed so we wont have to use EHA shirts

5. Potential hockey tournament in Rockingham

Rachel Hoey has been contacted by Jerome Buck. BMR are planning a tournament on the 8th/9th Oct. Possibly in Rockingham. Format would be 9 a side with 2 age divisions – 19's and U16's. We are holding off for now as it seems a little unorganised.

6. Rachel's development squad

Prior to school holidays – Rachel was having 8 (on average) attend each week. We are currently talking about ways we can make this more accessible to more kids.

Mouthguard clinic

EHA was given a chq for \$100 (for doing not very much). This has been handed to Rachel for banking.

Goalie equipment update

We have 'just' enough goalie gear to get us through this year. Could use another medium kit for 2021. John has advised that he plans to review the condition of all components of each kit toward end of season as some pieces are going to need to be replaced.

Trophies and wind up

We have begun discussing the above as we need to get trophy order in early this year (Due to COVID and trophies being made in China and related freight issues). Trophy King only have last year's stock and no new trophies will be available this year. We are focusing on how to reduce costs from last year. Some of the things we have discussed include:

- not having 4/5 finals
- Having people that have donated the trophy (like me) pay for it
- Cater the windups like we did last year by asking parents to provide food/drinks

Overall – the junior competition seems to be running smoothly. All volunteer positions have been filled.

Umpires have been very easy to find and we now know who is umpiring and when thanks to the efforts of Fraser, Kris and Tash to feed this info back to me. Kids are loving their hockey – mission accomplished 😊
