### What are Registration Fees?

Registration Fees is a fee charged by Calisthenics Victoria to be registered as a pupil/competitor.

This fee also covers insurance for the pupil/competitor in the event of an accident at classes and competitions. Without insurance, training is not permitted.

In addition to insurance, this payment allows students to participate in Victorian Metropolitan competitions. Registration fees of \$90 are payable directly to Calisthenics Victoria

### What is Competition Entry?

For a competitor to compete in a competition, a fee is charged per girl per item with additional fees charged for lighting effects and DLP's.



## What is a Costume Levy, and why is it different across other sections?

Costumes are an essential component of Calisthenics, as they enhance each item's performance.

A costume levy is a fee charged to all competitors for the use of costumes in the competition year; these could be

- Club owned premade costumes
- Hired Costumes
- New costumes

Costume Levies vary across all sections as some sections perform more items than others, and others may need larger quantities of costumes or materials.

At Findon, we try to reuse and refurbish costumes where possible. All costumes used and made remain property of Findon Calisthenics Club. Costume levies are kept to a modest \$\$\$ amount as it would be unfair and unrealistic to expect competitors to pay the true value of materials and embellishments.

If you choose to engage someone to help you sew costumes, please remember that you need to agree on payment terms – this is an agreement not covered by your fees.

## What is an Apparatus Levy?

A minimal apparatus levy is charged to a competitor to use the following items throughout the Calisthenics year.

- Rod
- Club
- Wigs
- Dance Shoes

These items remain the property of Findon Calisthenics Club.

Competitors in older sections have the option to purchase these items for a fee to keep them as their own

## What is a Service and Amenities Levy? Why is fundraising important?

Like many other organisations and businesses, Findon Calisthenics Club incurs running costs. To cover these costs, and a Service and Amenities Levy is charged and subsidised by fundraising.

- Cleaning Equipment- disinfectant, floor cleaner, bin liners, toilet cleaners, spray and wipes, cloths
- Calisthenics Victoria affiliation fees
- Calisthenics Victoria Team Registration Cost
- Dress Rehearsal and concert venue hire and technician fees
- First Aid Equipment
- Management Insurance
- Medals and Awards
- Musical Expenses
- Professional Development- allocation and applicable to all coaches for development at Findon
- Professional Indemnity Insurance
- Storage Expenses
- Subscriptions and renewals- website and email hosting, database management
- Work Cover Expenses
- Discounts-A portion of discounts offered to competitors of the club
