5. Association Reports President Report by Tony Barton

2023 has been a year of significant change for Manning Valley Hockey Association. There have been many new projects initiated that will continue to generate income for the Association.

The Manning Valley Hockey Association Junior space is looking good. It is an area where we are starting to see growth with the changes that we have implemented in the last 2 years. Manning Valley Hockey Association is hoping that our Junior programs and competitions will continue evolve and grow.

During 2024 our Target area will be upskilling our Coaches and filling the gaps where needed.

A big milestone for Manning Valley Hockey Association was the completion of the TLF. The TLF will be officially opened at the beginning of the 2024 season.

With the TLF in use Manning Valley Hockey Association will move the focus to maximising the usage of our venue. Manning Valley Hockey Association is hoping to be allocated several State Championships in 2024

During the construction of the TLF Frank Birkefeld worked with contractors to keep costs down which resulted in there being Grant money left remaining.

Manning Valley Hockey Association is currently assessing how we maximise the remaining grant funding. Adam Scarff has applied for a Grant Variation which we are hoping to get a response on over the next few weeks. Manning Valley Hockey Association's main focus will be field lighting.

Manning Valley Hockey Association will keep an eye out for any upcoming Grant opportunities moving forward.

Manning Valley Hockey Association has a \$25000 per year Electricity cost. Pending grant availability the Board of Management would like to see Solar Panels installed with options to be Battery ready.

The Hockey Shop settled in to the first year of business. Not only does it provide Manning Valley Hockey Association with a continued income its aim was to also assist players with a reduced playing cost.

Currently we have the Social Competition up and running again with 14 teams participating with our Indoor Competition is also starting to get some traction.

Early predictions are that 2024 may be a difficult year for membership numbers due to the rising cost of living. Manning Valley Hockey Association will be focusing on trying to keep membership costs to a minimum.

Overall 2023 has been a fantastic year of change. Thank you to our valued and committed volunteers, Thank you to our members, Clubs and the Club Committees for their support during 2023.

6. Financial Report

The 2023 Audit is in the process of being finalised. Manning Valley Hockey Association has recently moved into a higher Tax Bracket of \$250 000 and above which requires a comprehensive Audit to take place. Our Accountant has provided a draft copy of the Audit.

Manning Valley Hockey Association has grown in Income by \$100 000. The main contributors to the growth were the Bar, Canteen, Hockey Shop and Representative Uniform purchases.

It was a good first year with the new Reimbursement model in the Canteen. The cost of the reimbursement model was \$18,000. \$11,000 of which was covered by the player levy. Manning Valley Hockey Association absorbed the remaining \$7000.

- The Hockey Shop showed a profit of \$6000. We are still holding stock ready for sale in 2024.
- Hosting the Women's Masters during 2023 resulted in a \$10000 gain
- Our Loan repayments are currently \$50,000

Manning Valley Hockey Association's net worth was \$570,00 which up %10 from \$517, 000 2022.

During 2023 we have seen some good gains in sponsorship.

A big thank you to Club Taree who continue to be our Major sponsor. Special thanks also to Johnson & Mongan for their In kind donation overseeing accounting tasks.

Lynn Brettle moved a motion to provide Johnson & Mongan with a certificate to display in their office. Seconded by Adam Scarff

The field signage sponsorship also added to our gains. We thank the businesses that have come on board.

It is important for us to remember to support the Businesses that support Manning Valley Hockey Association.

Proposed Change to Section 9 Membership - Term 2. (2) Life members

SECTION 9 MEMBERSHIP

Existing rules Section 9 Members - Term 2. (2) Life members

2. (2) Life Membership

The granting of Life Membership is a great honour and should not be treated lightly. The criteria to assess the extent to which the nominee has made a significant contribution to the game of hockey in the Manning Region through consideration of the length of their active membership, the length and type of positions held, involvement as a player/organiser and personal hockey history.

On the average, one or less Life Memberships are likely to be able to be awarded each year Members must consider the nomination against the Life Membership criteria in light of the general principles. Each nomination must be considered on its merits. In considering the nomination, members are not to be influenced by any personal relationship with the nominee and are not to make direct comparisons with other Life Members, nominees or persons not nominated. To assist in its deliberations to see if the Nominee nomination satisfies the criteria for Life Member the Investigative Committee may request additional information from the nominator.

Granting Life Membership is a balancing exercise. Criteria are provided for guidance, but it is the overall contribution of the nominee that must be evaluated. There is necessarily some subjectivity in the granting of Life Membership. Nominees' strengths against the various criteria will vary. Some nominees will be extremely strong in some criteria but weaker against others, others will be more rounded.

- a. Criteria to be considered in granting Life Membership
- To be eligible for Life Membership the person:
- a. must have been a registered member of the Association for the period in which their service is considered
- b. have contributed to Manning Valley Hockey Association's to the degree necessary for Life Membership. A nominee will have fostered hockey in the Manning Region for a period of 10 years and made significant contributions while holding positions on the Manning Valley Hockey Association's Board of management and/or its sub committees (bearing in mind that mere

membership of such committees does not of its own mean a person has made significant contribution.

Where qualifying period was interrupted by Military Service, such time to be counted as continued membership, provided that:-

- i. The said member was considered a financial member of the Association although absent.
- ii. That they commenced active membership with the Association immediately following his return from Military Service.
- iii.. Where time absent is in excess of three years, such time be only counted as three years.
- iv. At all times this Rule to be at the discretion of the Judiciary and Investigation Committee and to be considered on its own merits.

b. Nomination of member/election of Life Member

The person is nominated for election as a Life Member by 2 members by way of written notice to the Secretary at least 28 days before a meeting to consider the nomination is held. The Secretary to provide a copy of the Nomination to a panel made up of persons from the the preceding season's Judiciary and Investigation Committee to see if the nomination meets the eligibility criteria.

- (ii) If the Judiciary and Investigation Committee is satisfied the criteria is correct the Secretary must make available to the secretaries of the association's member clubs of the nomination for Life Membership at least 14 days prior to the meeting which is to consider the nomination.
- (iii) At least 75% of members present and eligible to vote at the meeting held to consider the nomination, vote in favour of the electing the person as a Life Member.

Proposed rules Section 9 Members Term 2. (2) Life members

2. (2) Life Membership

The granting of Life Membership is a great honour and should not be treated lightly.

The criteria to assess the extent to which the nominee has made a significant contribution to the game of hockey in the Manning Region will consider the length of their active membership, the length and type of positions held (i.e., involvement as a player, coach, manager, umpire and administrator and personal hockey history).

Generally, one or less Life Memberships are likely to be able to be awarded each year.

Each nomination must be considered on its merits against the criteria.

In considering the nomination, Investigative committee members are not to be influenced by any personal relationship with the nominee, must declare any conflict of interest and are not to make direct comparisons with other Life Members, nominees or persons not nominated.

To assist in its deliberations to see if a nominee satisfies the criteria for Life Membership the Investigative Committee may request additional information from the nominators.

A. Criteria to be considered in granting Life Membership

To be eligible for Life Membership the person:

• must have been a registered member of the Association for the period in which their service is considered.

• have contributed to Manning Valley Hockey Association to the degree necessary for Life Membership.

A nominee will have fostered hockey in the Manning Region for a period of 10 years and made significant contributions while holding positions on the Manning Valley Hockey Association's Board of management and/or its sub committees (bearing in mind that mere membership of such committees does not of its own mean a person has made significant contribution.

B. Nomination of member/selection of Life Member

The person is nominated for selection as a Life Member by 2 members of the Association by way of written notice to the Secretary at least 28 days prior to the end of the season and addressing the criteria.

- The Secretary to provide a copy of the Nomination to the chair of the Investigative Committee who determine if the nomination meets the above criteria.
- If the Investigative Committee is satisfied the criteria is met, they will then consider the nomination and approve life membership.
- The chair of the investigative committee will then confidentially advise the President of the Association who will present life membership at a special function or annual general meeting.
- Should the investigative committee not support a nomination the chair will advise the President who will arrange for the members who made the nomination to be notified and the reasons why the nomination was not supported.
