#### **General Business**

**Judiciary Committee**- the results of the recent Judiciary Committee meetings were reviewed. Minutes are being prepared by the Judiciary Chair Brendan Bernie and will be followed up by the Secretary.

**Outstanding Rep Player fees 2023-** Cat presented a list of outstanding rep player fees relating to outdoor representation. The total is \$908.74 and it was agreed that Denise would be requested to follow these up and the players advised that they would be ineligible to play semi finals as they will be declared unfinancial due to the monies owing. Denise is to emphasis to Team Managers that players are not allowed to attend unless all fees are paid prior to the State Championships.

**Grand Final Preparations**- porta-loos, extra wheelie bins and the announcer have been booked and invitations issued to Patrons & Life Members. Nominations for perpetual trophies have been sent to Clubs yesterday and David will collate the votes and provide a list to the Leneves for trophies. Glenn will deliver trophies to Dave & Liz in the next few days.

Date for team lists for Juniors was set at the 18<sup>th</sup> August and Seniors 25<sup>th</sup> August. Clubs will be advised following the meeting.

**Umpires for Final Series**- it was agreed these would be appointed by Justine and Glenn and will come from the local umpire pool. Outside umpires will be organised for 1<sup>st</sup> Grade Men and Women as several local umpires have been contacted and declined.

**Burrawang Men 1**st **Grade**- Justine provided the cards for several matches where Burrawang Men's match card has been signed for all players by one person. The team was advised early in the season that this was not to occur, and Phil Lavers had given an undertaking to address. After some discussion it was agreed to treat those matches as forced losses. This action does not affect the current standing of the teams for semi-finals and as those matches are deducted from the available round calculation does not affect player qualification for semis.

This discussion led to reviewing the match card format and the small space to sign. David has contacted Revolutionise previously and they are unable to change the sizing. Justine has indicated that we can print sign on sheets with the cards and copies will be provided for the next meeting to review.

**Bowral Proposal for Howe Cup-** a copy of the Clubs email on running the Howe Cup is included with the minutes and was agreed by all on the Committee. David will advise Mindy tonight.

**Summer Hockey-** expressions of interest for running this competition will be emailed to Clubs this week along with the guidelines.

**Club Correspondence-** Glenn raised the matter of correspondence coming to the Executive Committee from individuals and not through their Clubs. It was agreed that the Committee members would remind their Clubs of this requirement.

**HNSW Umpire & Coaching Training**- Glenn gave an overview of HNSW's new programs which they will be rolling out to Associations for coaching and umpire training and clinics. They have developed on-line training for these roles and after completion of these will come out to Associations for face-to-face training.

Glenn will speak with HNSW after Grand Final to have us included in the program following which we will advise members to complete the on-line training.

Date of the next meeting was to be confirmed. A tentative date of the 30<sup>th</sup> August was proposed only if there were any matters that needed to be sorted for Final's series or Grand Final day otherwise the next meeting would be in September/October.
