General Business:

Motion to change the Winter Competition Rules.

Motion 1

That Teams Lists of eighteen (18) players are permitted

Background

In 2023 the change to clause 4 B winter playing competition rules that limit teams to only nominating 16 players (changed 8/2/23 from 18 reduced to 16). This rule change in the 2023 competition ultimately led to less people playing Hockey. The change made it unfair to teams with shift workers and first responders who are regularly on call, as teams with those players are left playing short and some of those shift workers and first responders aren't playing hockey as a result.

This motion is to revise the competition rule 4 B to:

b) Each Team should include at least eleven (11), but not more than eighteen (18) Players. Where matches are conducted under Nines format the team list should include at least nine (9) players but not more than sixteen (16) players.

Background

This motion is to change format of games from Halves to Quarters in line with FIH rule and HNSW protocols with 2 min breaks between quarters.

For reference: FIH rule 5.1 – A Match consists of four quarters of 15 minutes, an interval of 2 minutes between quarter 1 and 2 and between quarter 3 and 4 and a half-time interval of 5 minutes between quarter 2 and 3.

That finals which result in a draw are determined by 1:1 shoot-out competition in line with Appendix 9 FIH Tournament Regulations Outdoor Competitions

This motion is to change the last paragraph of Section 18 Clause E of the Winter Competition Rules to:

In the event that the match remains drawn after the completion of extra time to match will be decided by one-on-one shoot out. For the shoot-out competition five players from each team take a one-on-one alternatively against a defender from the other team. Each attempt will be limited to 8 seconds, timed on the scoreboard.
