### **2022 Treasurers Report**

We had a successful FULL season this year, however we were down on team and member numbers.

Sports Grant Account - S90

The opening bank balance was \$0 (1/10/2021) Closing balance was \$375.87 (30/9/2022)

A profit and loss statement and balance sheet is attached.

The association had a small profit this year, even though we were down on team numbers resulting in reduced income.

The umpiring costs did not quite break even but greatly improved from previous years. Additional costs were incurred for lawn maintenance due to the extreme wet weather resulting in faster growing and need to change contractors. The uniform sales does not show a profit however there is still stock in hand for next season.

A review of the Associations financial statements is being carried out and a copy of review will be provided to Clubs once received.

NOTE: The Office of Sports Grant for Mat Replacement Field 1 that was carried out this year is shown in the other income received, but as the payments were made from the S90 account it does not show in the profit and loss statement.

It is with great pleasure that I deliver this report on what can only be described as a successful season in hockey in the Southern Highlands.

In what I perceived may be a lean & cautious return, could not have been in further from the truth!

The Southern Highlands Hockey Association committee delivered a competition for a very pleasing 800 members. Only down by 28 from last year. But inclusive of summer hockey, we stand at 857 members. Given that a large majority of Associations in NSW have suffered significant losses over the past 3 years from financial, flood, covid or member numbers decreasing, we have been very fortunate to retain a healthy junior & senior competition of which I have you all, our members to thank.

Without you our members, we don't exist, & although the vast majority of members only are members to merely play hockey, your contribution to the game is vital, so thank you.

As President in my second term, I was able to learn from my first year & build on what I hoped were the association would like to receive to enjoy the season of hockey. As in any role, there is always so much to learn & room for growth, however with the support of a fantastic committee & mentors I hope that I delivered an enjoyable year for you all.

2022 saw the completion & the resurfacing of the Bedson – Isedale field, to now have 2 Hybrid surfaces for us all to enjoy playing hockey on. In light of this huge improvement, I would like to first & foremost thank the hard working efforts of 2 individuals, Dave McKay & Paul Sabitier who without their huge efforts behind the scenes, the project & successful grant application would not have come to fruition.

Grant funding & applications in the last 2 years has become increasingly difficult & the criteria harder to meet. With Dave's vast knowledge of the Turf committees' financials & operations & Paul's experience within Governance & submissions, these 2 minds together were successful in landing us \$335000.00 through the Office of Sport to make the dream a reality.

On the back end of the now 2 new hybrid fields & improvements that have taken place over the past 3 years, the Southern Highlands Turf Committee & Southern Highlands Hockey Association Committee, agreed that some improvements needed to take place to our Amenities. What started out as replacing the doors to stop patrons being locked inside, especially kids, evolved into a full refurbishment after excessive water damage was apparent in the adjoining walls.

At the cost to the Turf committee, we were able to deliver on cleaner, much more hygienic & up to date toilet facilities which was aimed at providing a better user friendly facility for all.

Although these are building project and are not part of the game of hockey, we are always looking to how better we can improve our hockey facility, & with the support of various grants we aim to deliver more projects I the coming years to improve the facility furthermore.

I would like to congratulate all our members for what was a great full season out of Covid. Although we are now living with this virus on a daily basis, you all proved we can get on with life & enjoy the sport we all so dearly love to play.

With 36 Junior teams & 33 Senior teams, we as a committee were heavily focused on keeping hockey going on a weekly basis despite the inclement weather. Because of this we were able to see a full competition & finals season in both juniors & seniors.

Umpiring has improved again this year, yet we would still like to see this grow. I would like to see the development of junior umpires continue into 2023 & the encouragement of all clubs to participate in this development. Without our umpires we don't have a game, but more importantly, without quality umpiring, the game suffers immensely, so one of my ambitions for the 2023 Association committee is focus on this development through the pathways of Umpire clinics & training & senior umpires coming on board to help train more & more juniors through the system.

I want to thank all the volunteers from each & every club for your countless hours you have given up this year to not only support your own clubs, run your committees, coach junior & senior teams as well give up time to help with rep teams as well. We are a grass roots sport & without you our volunteers, then like our playing members, we simply do not exist.

I would like to make special mention to the Southern Highlands Hockey Committee. The committee this year consisted of 8 Volunteers who worked constructively yet cohesively & very hard to deliver the 2022 season. It was a year of modernising how we operate & also implementing the revised rules to all members. I would like to thank Jo Bowie, Amy Hill, Blake Hill & Cassandra Rath for all that you have contributed to make my job as President so much easier & for sharing the load. To Cat Froome, who has delivered a highly successful season as Association Treasurer, I cannot thank you enough for grabbing the role with both hands & doing such a wonderful job.

Dave Mckay stepped back onto the committee this year in the role of Secretary & he has been instrumental in guiding not only myself but the entire committee through the governance & operations of the Association. With over 25 years' experience in & around the Southern Highlands Hockey Association, Dave has performed an outstanding job as our point of contact for all clubs & Hockey NSW.

Lastly but by no means least, I would like to thank my & your Vice President Melinda Armstrong. Mindy as we all know her, like Dave, is a wealth of all things Southern Highlands Hockey. Mindy has dedicated over 10 years or her time to help, grow, develop & the game that it is today. Mindy has worked on the modernising of the rules & its writings over this time & also as played a major role in the introduction of Revolutionise to the Association. Mindy not only helped setup the Association portal but helped every club in one way or another setup & develop theirs as well. When the competition & financials went from paper to this new system, Mindy has been there every step or the way.

Mindy's big passion is Umpire development & she has invested countless & freezing cold hours teaching all ages how to umpire & continues to do so, with the hope that we have such an in depth large pool of umpires for us all to benefit from.

Mindy has decided to step aside for the Association committee & no doubt enjoy life without the countless meetings, emails & at times heated debates & have a much deserved rest. Southern Highlands Hockey Centre Committee Financial Report 2022

Bank Balance \$287,196.63 Cr

Council Loan Field 2 Balance \$356,190.90 Dr

We were able to get a full competition completed in 2022 and the SHHCC recorded an operating profit of \$46,559.48 for the calendar year of 1st October 2021 to 30th September 2022. A copy of the profit and loss report is attached and has a comparison to the last season.

The major expenses for the Committee this year were meeting the majority of the cost of toilet renovation, (appox \$19,000) and the purchase a wheelchair and other minor repairs.

As you are all aware we successful in obtaining funding through the Office of Sport Regional Sport Facility Fund Infrastructure Grants program of \$335,000 to replace the synthetic mat on the Bedson/Isedale field. This project was completed for the start of the 2022 winter competition.

We have continued making our six-monthly repayments which are \$22,273.30. This has resulted in the loan balance reducing to the level recorded in the opening of the report.

The next project for the Committee still continues to be pursuing funding to construct a clubhouse type building within the centre, including new amenities and changerooms.

We thank the members of the executive for a successful 2022 season and for their continued support for Hockey which is has made the Hockey Centre and Association the successful sport it is in the Highlands.

### SHHA Presidents Report 2021

In my first year as President of the Southern Highlands Hockey Association, I can honestly say it has been a challenging, yet rewarding year in a time when everyone's life has been turned upside.

Not knowing what the year ahead was going to look like with us now living in a time of Covid 19, I expressed that I wanted to see the competition to get off to an early start, to give us all the best chance at playing as much hockey as possible. After a shorten half season in 2020, I put the Committee under added pressure to get their clubs organised & put teams together in a shorter time frame to start before Easter. I am pleased to say wee all worked hard together, members included & the 2021 Season hit the ground running in March rather than April as we normally do.

The season was met with an unseasonal amount of rain, so we were faced with deferred matches & forfeits which created an evolving draw which at times changed weekly. Add to this the deadly outbreak of the Delta variant of Covid & the committee were meeting at times once a fortnight to explore new ways to keep the hockey on the ground. Knowing the severity of Delta, we knew full well that our competition was fragile or could be shut down at any time.

I am pleased to say that we were able to complete the U7s, U9s & U11s competition & our U13s & U15s competitions continued right up to the elimination finals. Seniors having a longer season than the Juniors were lucky enough to fulfil between 16-18 rounds, however we weren't able to play out the final's series.

The committee agreed that as paying members & seeing we came so close to completing the season, we would award the respective competition leading teams in each division as competition winners for the season 2021. Due top lockdown conditions we have been unable to present these teams with the winner trophies, however this is scheduled to take place early in the new year along with the Association Perpetual trophies & Best & Fairest in each division.

The rep program for the Southern Highlands took an exciting turn this season with appointment of Dan & Tammy Parker as Rep coordinators and a new program to encourage more players to participate & as a result we sent away more rep teams than we have ever had before! A remarkable achievement in this difficult year, however I would like to thank Dan, Tammy, the selectors & all the team coaches & managers for offering up your time to create a veery successful Representative campaign. I can proudly say the future looks veery bright for all our junior players, especially at Representative level.

With the expansion of the Hockey complex in 2020, we saw an increase in member numbers from 2020, which without our members we don't have a competition. From 751 members in 2020 we have expanded to 828 in 2021. 37 Senior teams & 36 Junior teams. With our focus to grow the sport locally, the committee is still committed to growing further with 1000 members our target in the next few years.

The increase in member numbers has come about with the brand new Hybrid turf, Mackay Sharpe Field. This new field was a result of the Turf committee, in particular the hard work obtaining Grants by David Mackay & Paul Sabitier. With Season 2021 & new projects our secondary focus, David & Paul kindly volunteered to tackle yet another grant process to re surface Bedson Isedale Field which is our original sand based field & has served the hockey community now for 17 years. Yet again these fellows were successful in their grant application & we obtained \$335 000.00 via the Office of Sport Regional Sports Facility Fund to re surface this pitch with a Hybrid surface, matching Mackay Sharpe field. As a write this report the works to re surface are currently underway & will be ready before the season commencement in 2022! I would like to thank both David & Paul for the relentless efforts & passion to obtain these grant monies for our members & improve our playing facilities for many years to come. A wonderful legacy & credit to you both.

Other projects that have taken place is the installation of 3 new spectator shelters & seating to now provide more covered viewing areas for our spectators in perfect view of our 2 fields. This again was the result of volunteered time to apply for a grant via the Veolia Mulwaree Trust Scheme by Paul Sabitier, which he was successful in obtaining \$25 000.00! We thank you Paul for this tremendous effort & the opportunity to complete these shelters.

We have installed new bin stations at the complex, new seating, which was very generously donated by the Sharpe Family, courtesy of Sandra Sharpe & a new storage facility at the rear of the Canteen/Amenities building to cater for storage for representative supplies, Canteen & Amenities supplies. This project was kindly donated & undertaking by David Mackay & Rod South, of whom I would like to thank for their very kind donation to The Southern Highlands Hockey members.

With the support of the Executive committee, David Mackay & Melinda Armstrong worked together to modernise & update our current winter competition rules this year, a huge undertaking, however this project is now complete & the updated rules are ready to be sent out to clubs for comment, in time for season 2022. Thank you so very much to David & Melinda for this work, for which is an integral part of our competition.

I would like to offer a very generous thanks to all the volunteers this season, without you we just couldn't run. Coaches, Club committees, Umpire committee, Turf committee & of course the hard working Executive committee. I am very fortunate & forever grateful for the many, many hours the Executive have giving up keeping the season going this year. Fortunately, we were able to meet via Zoom on most occasions this season, however many hours were given up to do so. I thank each & everyone of you. You're an absolutely asset to the Southern Highlands Hockey Association & a credit to your clubs for what you do.

Moving into 2022, the 2021 executive have put forward agendas to work on for the incoming committee. We would like to see a more cohesive program put in place for the Umpiring committee & also workshop ways of streamlining this contentious issue. I believe in the recent years we have come a long way, in progressing our Umpire roster & program, yet as always we have more work to do.

We are currently looking at new projects to tackle in the coming year, of which will require grants funding to bring to fruition, however with the right, passionate people on board, I am confident we will achieve great things for all our members to enjoy.

Our big focus moving forward is to get involved with our schools & build on the Hockey NSW initiative for Hockey Clinics & Gala days for all students. The kids of today are the future of our sport tomorrow, & I will be working extremely hard in 2022 to showcase to our local school kids just how much fun & inclusive Hockey really is!

In closing I would like to thank you all for entrusting me to be your President for the season of 2021. It has been absolute pleasure & honour to serve you all & I look forward to the excitement of 2022 & what it brings for the Southern Highlands Hockey Association.

Well another year with covid interruptions, which unfortunately affected the season rounds and finals. Full fees were charged as greater than 75% of the season was played.

The opening bank balance was \$48.483.58 (1/10/2020) The closing bank balance was \$73,255.40 (30/9/2021).

A profit and loss statement and balance sheet is attached.

The association had a small profit, due to savings in umpire costs (full season not played out) and cleaning/waste removal for the shortened season. Additionally, there were no grand final costs paid out, although there will be an upcoming trophy bill, for perpetual trophies and premier winners to be awarded at the opening of the resurfaced turf early next year.

However, it should be noted that if the full season was played (and umpires paid) the fees received would not have covered the cost. (Approx \$3000 short)

The books have been sent to the auditors and are being finalised. A copy of the auditors statement will be provided to clubs once completed and signed.

### **Southern Highlands Hockey Centre Committee Financial Report 2021**

Bank Balance \$364,778.32 Cr

Council Loan Field 2 Balance \$400,919.40 Dr

With nearly a full year of competition completed in 2021 the SHHCC recorded an operating profit of \$60,595.17 for the calendar year of 1<sup>st</sup> October 2020 to 30<sup>th</sup> September 2021. A copy of the profit and loss report is attached and has a comparison to the last full season of competition pre-COVID which was 2019. The result between the last two full seasons has seen an increase in turf fee income of around 20% which is due to the growth in team registrations with completion of the second field.

The majority of the income growth is in the Senior competition and as we flagged last year is very positive news for the Association as it reflects the first increase in team numbers in nearly 10 years.

The major expenses for the Committee this year were fitting the seats in the spectator shelters (\$4,700) and the purchase of the shipping container at (\$5,000) to allow for more storage space.

While construction of the Mackay/Sharpe field was drawing to the end, the Committee were successful in obtaining funding through the Veolia Mulwarree Trust of \$15,207 to construct the three additional spectator shelters you now see on the hill. The total cost of this project was \$21,592.

Additionally in March we were advised of being successful in obtaining funding through the Office of Sport Regional Sport Facility Fund Infrastructure Grants program of \$335,000 to replace the synthetic mat on the Bedson/Isedale field. This project has now commenced although it is progressing very slowly due to the extended periods of rain, but will be complete before the start of the 2022 winter competition.

While the mat replacement cost is covered by the grant funding we will not know what additional costs, if any, will be incurred for repair of the shockpad until the mat is fully removed. The Committee have adequate funds in account to meet this cost if needed.

With completion of the Mackay/Sharpe field the interest free loan of \$445,466 provided by Council to assist us with this project was funded in October 2020. While Council have kindly given a deferment on repayments for loans to not-for-profit organisations, as a COVID support initiative, we have continued making our six-monthly repayments which are \$22,273.30. This has resulted in the loan balance reducing to the level recorded in the opening of the report.

It is intended that after the work is complete on replacing the mat on the Bedson/Isedale field, and assuming we don't face major costs on remediating the shockpad, we will make a further reduction to the loan with the aim to fully repaying Council in less than five years.

Having now completed the second field, upgrading the lighting on both fields to LED's, coupled with the current work to replace the mat on our original field, the Hockey Centre playing facilities are completely renewed which future proofs our sport.

The next project for the Committee is pursuing funding to construct a clubhouse type building within the centre, including new amenities and changerooms. We will be forwarding more details on this project to members shortly.

We congratulate the Executive Committee for their perserverance in running a competition over the last two years when faced with the many challenges presented by COVID. We also thank the members for their continued support for Hockey which is has made the Hockey Centre and Association the successful sport it is in the Highlands.
