The minimum number of Executive Committee members (5) were present to form a quorum under Section 17.4 of the Constitution.

Minutes were prepared by the Secretary.

Phil Lavers was in attendance as Burrawang Men representative in the absence of Blake Hill.

# **Umpire Coordinator Update**

The first order of business was an update from Brendon McDonald on the umpire situation. He indicated that excluding the Junior umpires currently in the Paid Program there were as few as 15 Senior umpires which is a dire situation for the Association and conduct of the competition.

While these few umpires have been rostered into the draw they are scheduled to many matches and the fear is they will burn out as we progress through the season. It was suggested by Alicia that we issue another call for umpires to put their hand up and this will be undertaken when the season draw issues.

Brendon has encouraged umpires who are rostered to speak with their Clubs to get substitutes to cut down their duties and he indicated that as long as the replacement is a competent umpire there is no restriction on them doing this.

A Group Chat is still to be setup for umpires to be able to contact each other for replacements.

Glenn thanked Brendon for his attendance and he left the meeting at 7.05pm.

# Minutes of Last Meeting 8th March 2023

Minutes of the last meeting were reviewed.

There were no outstanding items from those minutes. The only carry over outstanding item is the installation of a letterbox at the Hockey Centre which Glenn is attending to.

# Correspondence

There was no correspondence tabled.

### **General Business**

There was no general business tabled prior to the meeting and Glenn called for any items from the floor.

## **Burrawang Men-**

1. Phil raised a request from the 1<sup>st</sup> Grade Men side for a bye round to be inserted in their competition so they can have a week off every 3 rounds. There were no specific reasons given for the request other than citing work commitments and a desire to have a week off. Glenn pointed out that considering the fees that players paid he didn't believe it would be favoured by Clubs and considering that 1<sup>st</sup> Grade is the premier division of our competition those players should be in the best physical condition to be playing every round.

- Paul was asked for his opinion as Bowral representative, and he agreed with Glenn that it wouldn't be supported by his Club.
- 2. The Club has requested that the competition records for the season be retained in hard copy at the end of the season for referral by Clubs of individual match results if needed. Phil indicated that would have been helpful with their grading matter.

The Coordinator will download a copy of the competition results for each grade at the end of the season and upload it to Dropbox for future reference by Clubs if required.

- 3. T/O rostering was mentioned, and it was highlighted that the 1<sup>st</sup> Grade Men had not completed 3 duties. Glenn also brought to Phil's attention that they were swapping their duties with other Clubs to do their won matches. The reason for another team not involved in the match being rostered is to have an independent person completing the duties and a directive is to issue that no T/O duties are to be swapped. Phil undertook to sort this out with their 1<sup>st</sup> Grade Men.
- 4. As Burrawang Men have no Juniors and these players come from Revels Club, Phil asked whether they can be excluded from the Senior team lists as occurs with other Clubs and treated as Juniors playing up. It was indicated this can't happen as they are different Clubs. Glenn indicated the only way to address this was to merge the Clubs, or as David pointed out, change their constitution to form a Junior club which would then create the same restrictions in their Juniors.

Phil indicated that he was concerned that it restricts their player movements and was unfair, but it was pointed out to him that Mittagong Sports are in the same situation drawing players from Mittagong Hockey Club juniors.

# **Burrawang Women-**

- 1. Carolyn asked why the Umpiring Committee Guidelines, or the Representative Team Selection Guidelines were not on the website. David pointed outed out the umpiring guidelines are in the relative Umpire/TO section under the Winter Season 2023 tab, but the rep guidelines were not which has been corrected.
- 2. Revels 3<sup>rd</sup> Grade have a match that's been deferred under request by Mittagong due to Under 18 girls' representation. Carolyn questioned why they there was no flexibility in rescheduling and the teams being able to arrange these themselves. David pointed out that it was Revels and Burrawang Men's request that there be no variation from the scheduling as outlined in the rules be allowed due to an issue that arose with allowing flexibility in these arrangements last year. The minutes of the 21<sup>st</sup> June & 26<sup>th</sup> July 2022 Executive Committee meetings appearing on the website reflect this decision.

#### **Deferred Matches**

As a result of discussion on the Burrawang Revels deferred match Paul indicated that it was difficult to roster umpires for these matches as people were reluctant to come out on Sundays. He suggested that the Club requesting the deferred match be responsible for providing all the match officials i.e. umpires and T/O.

Following discussion this suggestion was adopted and the Coordinator will note this for any deferred matches going forward.

#### **Match Cards**

Justine raised the issue of cards in some cases being nearly illegible and asked if we can remind Clubs of the importance for ensuring that she can clearly read them when inputting results and stats. David will circulate a reminder with some umpire information to be forwarded to Clubs once the draw is complete.

Next meeting will be on Wednesday 24th May at Moss Vale Services Club.

There being no further business the meeting closed at 8.05pm.
