Southern Highlands Hockey Centre Committee (Turf Committee) Report

Current balance of the Turf Committee bank account is \$219,461.62 Cr. Balance of the interest free loan to Council for construction of the Mackay/Sharpe field is \$378,646.20 Dr. There is still an amount of \$98,482 to be returned to the SHHCC account from the Association when the last claim on the grant for the mat replacement is paid. This claim is being finalised with Office of Sport.

A wheelchair has been purchased as outlined at the last meeting and is in the changeroom for use to move injured players from the fields to the front gate. Details will be forwarded to Clubs.

General Business

Umpire Program

Mindy advised that although there had been a better response for 1st Grade umpires after she had spoken to several of them individually. There continues to be problems with the low numbers of senior umpires through both numbers nominated and those out from injury and COVID. Work will continue to increase participation in the program.

The shirts and whistles for the Junior umpires will be handed out this coming Saturday.

Late withdrawal of umpires scheduled on matches is creating significant pressure on the umpire contacts who in some cases are organising replacement umpires the night before matches. It was resolved to communicate to the umpire pool that they need to organise a replacement themselves for matches they are scheduled to officiate if they are withdrawing within 48 hours prior to the match.

Senior Draws

There were still some issues with the Senior draw that needed to be sorted and were discussed especially around scheduling of duty teams. This will be fixed, and the season draw issued after the

Grading Meeting.

Grading Meeting

The Grading Meeting was set for the 2nd May but due to a booking mix up with the RSL we can't use

that venue. Clubs to be advised in the coming days of the change in venue and or date.

Bedson/Isedale Field Opening and 2021 Presentation Day

The date for this event is confirmed as 15th May and invitations will be sent to dignitaries and Life

Members along with Clubs asked to organise award recipients to be available on the day if possible.

Water Bottle Filling Stations

Glenn received pricing for water filling stations which ranges between \$3-6000 for a pair to service both fields. It was decided to leave this for the present and have the spring taps refitted to each of

the taps outside the dugouts on the respective fields.

Indoor Competition

David noted several emails last year about reforming an Indoor competition and background to this was discussed. It was raised so that if the intention was to run this competition after the season that

preparations can start through the season. It was agreed to leave it for the time being but to issue an

email to Clubs in the next couple of months to gauge interest.

The next meeting will be Monday 23rd May 6.30 pm at Mittagong RSL Club.

Representative report

Training is well underway for the 18s and 15s boys and girls. All teams have had the last two weeks off except the 15s boys who trained Sunday 24th. But all training will recommence this Sunday.

All uniforms are ordered for these age groups. I expected them to arrive in 2-3 weeks.

The 18s boys we now have 15 players attending 13 true age and only two young. I've got a clearance for Tom Morton to compete with the 18s from Illawarra. As his origin is ours there is no issues with him competing with us. Currently all paid their fees except 5, but still have just over 2 weeks before they compete. There fees have come in at in at \$150 per player. This includes their photo package.

The 18s girls have 14 competing players 2 required release from Illawarra this was due to them registering to play in their 18s competition as we don't have one. All \$100 deposit have been collected. Tash has invoices to give to each player at Sunday's training their fees remaining have come to a total of \$367 this is just over the estimated \$450. This includes their Photos package.

The 15s girls have 31 players 28 true age and 3 underage players. the blues team has 15 players and the gold team has 16. I have a great turn out for selectors on first day with 5 being available and 3 who turned up the second week. The selectors feedback made easy placement for players into their trialed teams. The girls have Moorebank training carnival on the 22nd May which I've received nominations form for. Waiting on confirmation of numbers incase we are unable to send the two full teams. I've received 17 \$100 deposit so far

And will start actively chasing now that Easter is over and all players have registered. Michelle has worked out there costing remaining at \$230 per player.

The 15s boys have 14 players 12 true age and 2 underage. I've just received details from accommodation so that we can work out the costing for the boys with Kelleah Dawes on the weekend. But as they have 7 weeks before they compete we have plenty of time.

I've sent an email to the 13s boys about trials for the 8th and 15th of May, as we have 18 true age players they will need to trial with 2 to be placed in shadow list along with a underage player who I've already informed the parents that due to age he'll automatically be on the shadow list. Damian is all cleared with wwc and is very keen to start training. Tash has sent emails to all 13s to get parents for fundraising to try and lower the fees as currently they are looking at \$600-700 levy.

The 13 girls have 13 players one from Wagga who played with them last year and very keen to continue playing with our girls. Hoping to get training underway after 18 boys compete but will confirm this with Glenn when he would like to start as there is 10 weeks they have some time.

Rep account sitting at \$7722.13

We have \$2700 in outstanding nominations fees for the 2x 18s at \$1350 each. I expect the boys turf fee in the next week or so.
