Treasurers Report

Southern Highlands Hockey Centre Committee (Turf Committee) Report

Current balance of the Turf Committee bank account is \$219,461.62 Cr. Balance of the interest free loan to Council for construction of the Mackay/Sharpe field is \$378,646.20 Dr. There is still an amount of \$98,482 to be returned to the SHHCC account from the Association when the last claim on the grant for the mat replacement is paid. A variation for the Office of Sport grant has been submitted to allow us to claim the difference between the Polytan contract and the grant funding which is approximately \$11,000. This was due to the mat replacement coming in under budget.

The next priority for the SHHCC is the carpark and admin building. Council are being written to in the following week in respect to getting the design work and approvals in place for the carpark. The admin/amenities building has been approved by Council.

Representative Team Coordinator Report

Tammy Parker forwarded a written report which is included with these minutes.

The Executive Committee received a letter from Tammy last week indicating that she wouldn't be continuing as the Rep Team Coordinator after the last team has been away on the 24th July and will wind things up as at 30th July.

The Committee thanks Tammy for the work she has done with the representative team program over the last two seasons and will discuss options for the position at the next meeting.

Glenn will forward an email of thanks to Tammy on the Executive Committees behalf in the coming week.

Correspondence

No general correspondence was received.

General Business

Umpiring

Glenn raised concerns about the behaviour of players in a Men's 2nd Grade game on the preceding Saturday. After discussion it generally agreed that there was an issue with behaviour in mostly Men's 1st and 2nd Grade games, but also a lack of respect towards umpires across the senior grades with decisions questioned and many instances of dissent.

Accordingly, it was agreed that a meeting of senior umpires would be held to brief them on expectations of what is acceptable behaviour on field and to get their feedback on the general behaviour of players.

Mindy and Dan will organise contact with the umpires and the meeting room has been booked at the Mittagong RSL for the 7th June.

Parking

Jo raised the issue of people still parking in the no-standing zone around the corner of Meranie & Colo Streets. We have emailed all members around 6 weeks ago, but the problem still persists and there is concern that eventually an accident will occur as trucks use that road frequently.

David will contact the Police and request they patrol the area especially on the peak periods of Saturday and Junior nights and book those parking illegally.

Goal Keeping Clinic

We received a flyer from Toni Cronk who is an ex-Hockeyroo goalie who is conducting clinics down the east coast over the next few months. It was agreed this would be of value to Clubs and will email the flyer to all Clubs and Schools to ask for their interest in us making a booking.

Bedson/Isedale Field Opening and 2021 Presentation Day

The field opening was great success and well supported by members. We had very good feedback from the new CEO of Hockey NSW Emma Highwood on our facility and she was keen to assist wherever HNSW can with our building programs and development of our sport. Our local member Nathaniel Smith also spoke highly of the work completed and gave a similar undertaking to help us with the next phases of development which are the Administration/Amenities building and the Carpark.

Following the opening and presentation a game was held with Steve Bedson and Glen Isedale leading invitational 11's sides and after a hard-fought game the result was Nil all.

The presentation of the 2021 winners was held and there was some misunderstanding about the winner of the 1st Grade Mens competition which was recorded on the day as Mittagong. The 2021 Executive Committee had determined that it was in fact Robertson and they will be contacted and declared the winner.

Social Media

At the last meeting it was briefly discussed the need for the Association to have a robust social media presence to promote our sport and increase it's exposure in the Highlands. Blake has volunteered his services to do some work on our Facebook site and as a first step have Meegan set him up with full administration access and he will start working on site setup and other enhancements.
