I hereby acknowledge that:

- **1.** I have been selected by Toowoomba Softball Association Inc ("TSA") as a member of a Toowoomba representative softball squad/team.
- 2. I shall remain a member of the TSA representative softball squad/team, in which I have been selected, until (whichever is the earlier):
 - i) my withdrawal from the squad/team;
 - ii) my dismissal from the squad/team; or
 - iii) selection of the next TSA representative squad/team:
- **3.** As a member of a Toowoomba representative softball squad/team, I am expected to display a high standard of behaviour, both on and off the playing field, and not to engage in conduct which is or is likely to be prejudicial or injurious to the interests or reputation of softball;
- **4.** Conduct which is likely to be prejudicial or injurious to the interest or reputation of softball will include BUT WILL BY NO MEANS BE LIMITED TO:
 - i) striking a player, an official or spectator;
 - ii) abusing an umpire of other game official before, during or after a game;
 - iii) abusing a player or spectator;
 - iv) using obscene or indecent language or audible sounds, or making obscene or indecent gestures to any person before, during or after the game or at any softball related function;
 - v) endeavouring to undermine the authority, or disobeying the instructions or orders of a team manager, coach, umpire or other official, or of my team captain;
 - vi) failing at any time to conform to standards of behaviour, or to comply with rules of conduct set down from time to time by TSA for TSA representative players and officials.
- **5.** If it is considered by the Executive Committee of TSA, upon the report of any person, that I may have been guilty of conduct prejudicial or injurious to the interests or reputation of softball, I may be cited to appear before the TSA Tribunal to answer a charge to that effect and if, after the matter is heard by the TSA Tribunal, I am found guilty of the charge, I may be penalised by:
 - i) lifetime suspension from the participation in softball as a player and/or official within Queensland;
 - ii) suspension from participation in softball, as a player and/or as an official, for a specific period of time (being less than a lifetime) or a specific number of fixtures;
 - iii) lifetime disqualification from membership of any district softball association and/or of the Association;
 - iv) disqualification from membership of any district softball association and/or of the Association for specific period of time (being less than a lifetime);
 - v) disqualification from eligibility to be selected for, or to participate in (as the case may be) specified softball activities including, but by no means limited to , membership of representative teams and development squads, attendance at seminars or camps; attendance at seminars or camps;
 - vi) disqualification from eligibility to receive incentives or other assistant from the Association;
