# RULES OF THE VICTORIAN KENDO RENMEI INCORPORATED

#### Note

The persons who from time to time are Members of the Association are an incorporated association by the name given in rule 1 of these Rules.

Under section 46 of the **Associations Incorporation Reform Act 2012**, these Rules are taken to constitute the terms of a contract between the Association and its Members.

# PART 1—PRELIMINARY

#### 1 Name

1) The name of the incorporated association is "Victorian Kendo Renmei Incorporated".

#### Note

Under section 23 of the Act, the name of the association and its registration number must appear on all its business documents.

## 2 Purposes

- 1) This is the statement of the Victorian Kendo Renmei Incorporated and was adopted by Special Resolution at a public meeting of the Victorian Kendo Renmei Incorporated on 20 June 2021.
- 2) The purposes of the association are:
  - a) To promote interest in Kendo, laido and Jodo;
  - b) To promote good fellowship among those interested in Kendo, laido and Jodo;
  - c) To educate, train, coach and encourage Members of the Association;
  - d) To support and encourage a diverse and inclusive membership of the Association;
  - e) To represent and encourage the aims, objects and interests of the Australian Kendo Renmei in Victoria; and
  - f) To do all such things and acts conducive to the furtherance of the objects and interests of the Association.

## 3 Financial year

1) The Financial Year of the Association is each period of 12 months ending on 31 December.

## 4 Definitions

In these Rules-

**Absolute Majority**, of the Committee, means a majority of the Committee Members currently holding office and entitled to vote at the time (as distinct from a majority of Committee Members present at a Committee meeting);

*Affiliated Club* means a club or dojo of the Association admitted in accordance with the requirements of Association;

Associate Member means a Member referred to in rule 16(1);

Association means the Victorian Kendo Renmei Incorporated (ABN: 60 252 737 207)

*Chairperson*, of a General Meeting or Committee Meeting, means the person chairing the meeting as required under rule 61;

Committee means the Committee having management of the business of the Association;

Committee Meeting means a meeting of the Committee held in accordance with these Rules;

Committee Member means a Member of the Committee elected or appointed under Division 3 of Part 5;

*Disciplinary Appeal Meeting* means a meeting of the Members of the Association convened under rule 23(3);

Disciplinary Meeting means a meeting of the Committee convened for the purposes of rule 25;

Disciplinary Sub-committee means the sub-committee appointed under rule 23;

Financial Year means the 12 month period specified in rule 3;

*General Meeting* means a General Meeting of the Members of the Association convened in accordance with Part 4 and includes an annual General Meeting, a special General Meeting and a disciplinary appeal meeting;

Honorary Member means a Member appointed under Rule 17(2);

Honorary Life Member means a Member appointed under Rule 17(2);

*Member* means a member of the Association;

Member Entitled to Vote means a Member who under rule 15(2) is entitled to vote at a General Meeting;

Membership Fee means the fee specified in rule 14;

Membership Year means the 12 month period specified in rule 14(1);

*Special Resolution* means a resolution that requires not less than three-quarters of the Members voting at a General Meeting, whether in person or by proxy, to vote in favour of the resolution;

State Council means the body defined under Division 1 of Part 5;

*the Act* means the **Associations Incorporation Reform Act 2012** and includes any regulations made under that Act;

the Registrar means the Registrar of Incorporated Associations;

the VKR Registrar means the Registrar of the Association.

# PART 2—POWERS OF ASSOCIATION

#### 5 Powers of Association

- 1) Subject to the Act, the Association has power to do all things incidental or conducive to achieve its purposes.
- 2) Without limiting subrule (1), the Association may
  - a) acquire, hold and dispose of real or personal property;
  - b) open and operate accounts with financial institutions;
  - c) invest its money in any security in which trust monies may lawfully be invested;
  - d) raise and borrow money on any terms and in any manner as it thinks fit;
  - e) secure the repayment of money raised or borrowed, or the payment of a debt or liability;
  - f) appoint agents to transact business on its behalf;
  - g) enter into any other contract it considers necessary or desirable.
- The Association may only exercise its powers and use its income and assets (including any surplus) for its purposes.

## 6 Not for profit organisation

- 1) The Association must not distribute any surplus, income or assets directly or indirectly to its Members.
- 2) Subrule (1) does not prevent the Association from paying a Member
  - a) reimbursement for expenses properly incurred by the Member; or
  - b) for goods or services provided by the Member-

if this is done in good faith on terms no more favourable than if the Member was not a Member.

#### Note

Section 33 of the Act provides that an incorporated association must not secure pecuniary profit for its Members. Section 4 of the Act sets out in more detail the circumstances under which an incorporated association is not taken to secure pecuniary profit for its Members.

# PART 3—MEMBERS, DISCIPLINARY PROCEDURES AND GRIEVANCES

## **Division 1—Membership**

## 7 Minimum number of Members

1) The Association must have at least 7 Members.

## 8 Who is eligible to be a Member

1) Any person who supports the purposes of the Association and is a Member of an Affiliated Club is eligible for Membership.

## 9 Application for Membership

- 1) To apply to become a Member of the Association, a person must pay the Association's Membership Fee determined under Rule 14(2), either:
  - a) to an Affiliated Club in the manner determined by that Affiliated Club; or
  - b) if permitted, directly to the VKR Registrar in the manner determined by the VKR Registrar.
- 2) An Affiliated Club must submit any applications to become a Member of the Association and those Membership Fees collected from persons applying to be a Member to the VKR Registrar.

#### Note

The Membership Fee is the fee (if any) determined by the Association under Rule 14(2).

## 10 Consideration of application

- 1) As soon as practicable after an application for Membership is received, the VKR Registrar must decide whether to accept or reject the application.
- 2) The VKR Registrar must notify the applicant in writing of its decision as soon as practicable after the decision is made.
- 3) If the VKR Registrar rejects the application, it must return any money accompanying the application to the applicant.
- 4) No reason need be given for the rejection of an application.

#### 11 New Membership

- 1) If an application for Membership is approved, then the VKR Registrar must, as soon as practicable, enter the name and registered address of the new Member, and the date of becoming a Member in the register of Members.
- 2) A person becomes a Member of the Association and, subject to Rule 15(2), is entitled to exercise his or her rights of Membership from the date, whichever is the later, on which
  - a) the VKR Registrar approves the person's Membership; or
  - b) the Affiliated Club pays the Membership Fee on behalf of the person applying for Membership.

## 12 Application to become an Affiliated Club

- 1) To apply to become an Affiliated Club, a club or dojo must have at least one financial Member of the Association and submit an application via the form approved by the Committee to the President of the Association stating that the club or dojo:
  - a) Wishes to become an Affiliated Club of the Association; and
  - b) Supports the purposes of the Association; and
  - c) Agrees to comply with these Rules.
- At the date of the making of these Rules, any club or dojo that is generally recognised by the Committee and includes at least one financial Member of the Association is deemed to be an Affiliated Club.

## 13 Consideration of application to become an Affiliated Club

- 1) As soon as practicable after an application for an Affiliated Club is received, the Committee must decide whether to accept or reject the application.
- 2) The Committee must notify the applicant in writing of its decision as soon as practicable after the decision is made.
- 3) No reason need be given for the rejection of an application.

#### 14 Annual subscription and fee on joining

- 1) The Membership Year of the Association is each period of 12 months ending on 30 June.
- 2) At each annual General Meeting, the Association must determine
  - a) the amount of the annual Membership Fee (if any) for the following Membership Year; and
  - b) the date for payment of the Membership Fee.
- 3) The Association may determine that a lower Membership Fee is payable by associate Members.
- 4) The Association may determine that any new Member who joins after the start of a Membership Year must, for that Membership Year, pay a fee equal to
  - a) the full Membership Fee; or
  - b) a pro rata Membership Fee based on the remaining part of the Membership Year; or
  - c) a fixed amount determined from time to time by the Association.
- 5) The rights of a Member (including the right to vote) who has not paid the Membership Fee by the due date are suspended until the subscription is paid.

#### **15** General rights of Members

- 1) A Member of the Association who is entitled to vote has the right
  - a) to receive notice of General Meetings and of proposed Special Resolutions in the manner and time prescribed by these Rules; and
  - b) to submit items of business for consideration at a General Meeting; and
  - c) to attend and be heard at General Meetings; and
  - d) to vote at a General Meeting; and
  - e) to have access to the minutes of General Meetings and other documents of the Association as provided under rule 93; and

- f) to inspect the register of Members, subject to relevant State and Commonwealth privacy legislation.
- 2) A Member is entitled to vote if
  - a) the Member is a Member other than an associate Member; and
  - b) more than 10 business days have passed since he or she became a Member of the Association; and
  - c) the Member's Membership rights are not suspended for any reason.

#### **16** Associate Members

- 1) Associate Members of the Association include
  - a) any Members younger than 18 years of age or whose 18<sup>th</sup> birthday occurs on or after the first day of the current Membership Year;
  - b) persons not active participants in Kendo, laido or Jodo but who are interested in its promotion;
  - c) practitioners of other related martial arts as determined by the Committee (for example, Naginatado); and
  - d) any other category of Member as determined by Special Resolution at a General Meeting.
- 2) An associate Member must not vote but may have other rights as determined by the Committee or by resolution at a General Meeting.

## 17 Life Members

- 1) Any person may be appointed an Honorary Member or Honorary Life Member of the Association in recognition of services rendered in promoting the interests and objects of the Association.
- 2) The appointment of such a Member must be made by Special Resolution at a properly constituted General Meeting or Special General Meeting of the Association.
- 3) An Honorary Member is not required to pay the Membership Fee for the Membership Year as specified by the Special Resolution made in accordance with Rule 17(2).
- 4) An Honorary Life Member is not required to pay the Membership Fee in any Membership Years for so long as that Member remains an Honorary Life Member.
- 5) Honorary Members and Honorary Life Members are entitled to the rights of Members as described in Rule 15.

## 18 Rights not transferable

1) The rights of a Member are not transferable and end when Membership ceases.

## 19 Ceasing Membership

- 1) The Membership of a person ceases on resignation, expulsion or death.
- 2) If a person ceases to be a Member of the Association, the Secretary must, as soon as practicable, enter the date the person ceased to be a Member in the register of Members.

## 20 Resigning as a Member

1) A Member may resign by notice in writing given to the Association.

#### Note

Rule 92(3) sets out how notice may be given to the association. It includes by post or by handing the notice to a Member of the Committee.

- 2) A Member is taken to have resigned if
  - a) the Member's annual subscription is more than 12 months in arrears; or
  - b) where no annual subscription is payable
    - i) the Secretary has made a written request to the Member to confirm that he or she wishes to remain a Member; and
    - ii) the Member has not, within 3 months after receiving that request, confirmed in writing that he or she wishes to remain a Member.

#### 21 Register of Members

- 1) The VKR Registrar must keep and maintain a register of Members that includes
  - a) for each current Member-
  - b) the Member's name;
  - c) the address for notice last given by the Member;
  - d) the date of becoming a Member;
  - e) if the Member is an associate Member, a note to that effect;
  - f) any other information determined by the Committee; and
  - g) for each former Member, the date of ceasing to be a Member.
- 2) Any Member may, at a reasonable time and free of charge, inspect the register of Members, subject to relevant State and Commonwealth privacy legislation.

#### Note

Under section 59 of the Act, access to the personal information of a person recorded in the register of Members may be restricted in certain circumstances. Section 58 of the Act provides that it is an offence to make improper use of information about a person obtained from the Register of Members.

#### **Division 2—Disciplinary action**

#### 22 Grounds for taking disciplinary action

- 1) The Association may take disciplinary action against a Member in accordance with this Division if it is determined that the Member
  - a) has failed to comply with these Rules; or
  - b) refuses to support the purposes of the Association; or
  - c) has engaged in conduct prejudicial to the Association.

### 23 Disciplinary subcommittee

- If the Committee is satisfied that there are sufficient grounds for taking disciplinary action against a Member, the Committee must appoint a disciplinary Subcommittee to hear the matter and determine what action, if any, to take against the Member.
- 2) The Members of the disciplinary Subcommittee
  - a) may be Committee Members, Members of the Association or anyone else; but
  - b) must not be biased against, or in favour of, the Member concerned.

## 24 Notice to Member

- 1) Before disciplinary action is taken against a Member, the Secretary must give written notice to the Member
  - a) stating that the Association proposes to take disciplinary action against the Member; and
  - b) stating the grounds for the proposed disciplinary action; and
  - c) specifying the date, place and time of the meeting at which the disciplinary subcommittee intends to consider the disciplinary action (the *disciplinary meeting*); and
  - d) advising the Member that he or she may do one or both of the following-
  - e) attend the disciplinary meeting and address the disciplinary Subcommittee at that meeting;
  - f) give a written statement to the disciplinary Subcommittee at any time before the disciplinary meeting; and
  - g) setting out the Member's appeal rights under rule 26.
- 2) The notice must be given no earlier than 28 days, and no later than 14 days, before the disciplinary meeting is held.

## 25 Decision of Subcommittee

- 1) At the disciplinary meeting, the disciplinary Subcommittee must
  - a) give the Member an opportunity to be heard; and
  - b) consider any written statement submitted by the Member.
- 2) After complying with subrule (1), the disciplinary Subcommittee may
  - a) take no further action against the Member; or
  - b) subject to subrule (3)
    - i) reprimand the Member; or
    - ii) suspend the Membership rights of the Member for a specified period; or
    - iii) expel the Member from the Association.
- 3) The disciplinary Subcommittee may not fine the Member.
- 4) The suspension of Membership rights or the expulsion of a Member by the disciplinary Subcommittee under this rule takes effect immediately after the vote is passed.

## 26 Appeal rights

1) A person whose Membership rights have been suspended or who has been expelled from the Association under rule 25 may give notice to the effect that he or she wishes to appeal against the suspension or expulsion.

- 2) The notice must be in writing and given
  - a) to the disciplinary Subcommittee immediately after the vote to suspend or expel the person is taken; or
  - b) to the Secretary not later than 48 hours after the vote.
- 3) If a person has given notice under subrule (2), a disciplinary appeal meeting must be convened by the Committee as soon as practicable, but in any event not later than 21 days, after the notice is received.
- 4) Notice of the disciplinary appeal meeting must be given to each Member of the Association who is entitled to vote as soon as practicable and must
  - a) specify the date, time and place of the meeting; and
  - b) state
    - i) the name of the person against whom the disciplinary action has been taken; and
    - ii) the grounds for taking that action; and
    - iii) that at the disciplinary appeal meeting the Members present must vote on whether the decision to suspend or expel the person should be upheld or revoked.

## 27 Conduct of disciplinary appeal meeting

- 1) At a disciplinary appeal meeting
  - a) no business other than the question of the appeal may be conducted; and
  - b) the Committee must state the grounds for suspending or expelling the Member and the reasons for taking that action; and
  - c) the person whose Membership has been suspended or who has been expelled must be given an opportunity to be heard.
- 2) After complying with subrule (1), the Members present and entitled to vote at the meeting must vote by secret ballot on the question of whether the decision to suspend or expel the person should be upheld or revoked.
- 3) A Member may not vote by proxy at the meeting.
- 4) The decision is upheld if not less than three quarters of the Members voting at the meeting vote in favour of the decision.

## **Division 3—Grievance procedure**

## 28 Application

- 1) The grievance procedure set out in this Division applies to disputes under these Rules between
  - a) a Member and another Member;
  - b) a Member and the Committee;
  - c) a Member and the Association.
- 2) A Member must not initiate a grievance procedure in relation to a matter that is the subject of a disciplinary procedure until the disciplinary procedure has been completed.

## 29 Parties must attempt to resolve the dispute

1) The parties to a dispute must attempt to resolve the dispute between themselves within 14 days of the dispute coming to the attention of each party.

## 30 Appointment of mediator

- 1) If the parties to a dispute are unable to resolve the dispute between themselves within the time required by rule 32, the parties must within 10 days
  - a) notify the Committee of the dispute; and
  - b) agree to or request the appointment of a mediator; and
  - c) attempt in good faith to settle the dispute by mediation.
- 2) The mediator must be
  - a) a person chosen by agreement between the parties; or
  - b) in the absence of agreement—
  - c) if the dispute is between a Member and another Member—a person appointed by the Committee; or
  - d) if the dispute is between a Member and the Committee or the Association—a person appointed or employed by the Dispute Settlement Centre of Victoria.
- 3) A mediator appointed by the Committee may be a Member or former Member of the Association but in any case must not be a person who
  - a) has a personal interest in the dispute; or
  - b) is biased in favour of or against any party.

## 31 Mediation process

- 1) The mediator to the dispute, in conducting the mediation, must
  - a) give each party every opportunity to be heard; and
  - b) allow due consideration by all parties of any written statement submitted by any party; and
  - c) ensure that natural justice is accorded to the parties throughout the mediation process.
- 2) The mediator must not determine the dispute.

## 32 Failure to resolve dispute by mediation

If the mediation process does not resolve the dispute, the parties may seek to resolve the dispute in accordance with the Act or otherwise at law.

# PART 4—GENERAL MEETINGS OF THE ASSOCIATION

## 33 Annual General Meetings

- 1) The Committee must convene an annual General Meeting of the Association to be held within 5 months after the end of each Financial Year.
- 2) Despite subrule (1), the Association may hold its first annual General Meeting at any time within 18 months after its incorporation.
- 3) The Committee may determine the date, time and place of the annual General Meeting.
- 4) The ordinary business of the annual General Meeting is as follows
  - a) to confirm the minutes of the previous annual General Meeting and of any special General Meeting held since then;
  - b) to receive and consider
    - i) the annual report of the Committee on the activities of the Association during the preceding Financial Year;
    - ii) the financial statements of the Association for the preceding Financial Year submitted by the Committee in accordance with Part 7 of the Act; and
    - iii) the auditor's report of the financial statements of the Association;
  - c) to elect the Members of the Committee; and
  - d) to confirm or vary the amounts (if any) of the annual Membership Fee.
- 5) The annual General Meeting may also conduct any other business of which notice has been given in accordance with these Rules.

## 34 Special General Meetings

- 1) Any General Meeting of the Association, other than an annual General Meeting or a disciplinary appeal meeting, is a special General Meeting.
- 2) The Committee may convene a special General Meeting whenever it thinks fit.
- 3) No business other than that set out in the notice under rule 36 may be conducted at the meeting.

#### Note

General business may be considered at the meeting if it is included as an item for consideration in the notice under rule 36 and the majority of Members at the meeting agree.

#### 35 Special General Meeting held at request of Members

- 1) The Committee must convene a special General Meeting if a request to do so is made in accordance with subrule (2) by at least 10% of the total number of Members.
- 2) A request for a special General Meeting must
  - a) be in writing; and
  - b) state the business to be considered at the meeting and any resolutions to be proposed; and
  - c) include the names and signatures of the Members requesting the meeting; and
  - d) be given to the Secretary.
- If the Committee does not convene a special General Meeting within one month after the date on which the request is made, the Members making the request (or any of them) may convene the special General Meeting.

- 4) A special General Meeting convened by Members under subrule (3)
  - a) must be held within 3 months after the date on which the original request was made; and
  - b) may only consider the business stated in that request.
- 5) The Association must reimburse all reasonable expenses incurred by the Members convening a special General Meeting under subrule (3).

## 36 Notice of General Meetings

- 1) The Secretary (or, in the case of a special General Meeting convened under rule 35(3), the Members convening the meeting) must give to each Affiliated Club of the Association
  - a) at least 21 days' notice of a General Meeting if a Special Resolution is to be proposed at the meeting; or
  - b) at least 14 days' notice of a General Meeting in any other case.
- 2) The notice must
  - a) specify the date, time and place of the meeting; and
  - b) indicate the general nature of each item of business to be considered at the meeting; and
  - c) if a Special Resolution is to be proposed—
  - d) state in full the proposed resolution; and
  - e) state the intention to propose the resolution as a Special Resolution; and
  - f) comply with rule 37(5).
- 3) This rule does not apply to a disciplinary appeal meeting.

#### Note

Rule 26(4) sets out the requirements for notice of a disciplinary appeal meeting.

#### 37 Proxies

- 1) A Member may appoint another Member as his or her proxy to vote and speak on his or her behalf at a General Meeting other than at a disciplinary appeal meeting.
- 2) The appointment of a proxy must be in writing and signed by the Member making the appointment.
- 3) The Member appointing the proxy may give specific directions as to how the proxy is to vote on his or her behalf, otherwise the proxy may vote on behalf of the Member in any matter as he or she sees fit.
- 4) If the Committee has approved a form for the appointment of a proxy, the Member may use any other form that clearly identifies the person appointed as the Member's proxy and that has been signed by the Member.
- 5) Notice of a General Meeting given to a Member under rule 36 must
  - a) state that the Member may appoint another Member as a proxy for the meeting; and
  - b) include a copy of any form that the Committee has approved for the appointment of a proxy.
- 6) A form appointing a proxy must be given to the Chairperson of the meeting before or at the commencement of the meeting.
- 7) A form appointing a proxy sent by post or electronically is of no effect unless it is received by the Association no later than 24 hours before the commencement of the meeting.

#### 38 Use of technology

- 1) A Member not physically present at a General Meeting may be permitted to participate in the meeting by the use of technology that allows that Member and the Members present at the meeting to clearly and simultaneously communicate with each other.
- For the purposes of this Rule, a Member participating in a General Meeting as permitted under subrule
   (1) is taken to be present at the meeting and, if the Member votes at the meeting, is taken to have voted in person.

## 39 Quorum at General Meetings

- 1) No business may be conducted at a General Meeting unless a quorum of Members is present.
- 2) The quorum for a General Meeting is the presence (physically, by proxy or as allowed under rule 38) of:
  - a) a minimum of 7 Members in total; and
  - b) that at least one third of the number of Affiliated Clubs are each represented by at least one Member.
- If a quorum is not present within 30 minutes after the notified commencement time of a General Meeting
  - a) in the case of a meeting convened by, or at the request of, Members under rule 35—the meeting must be dissolved;

#### Note

If a meeting convened by, or at the request of, Members is dissolved under this subrule, the business that was to have been considered at the meeting is taken to have been dealt with. If Members wish to have the business reconsidered at another special meeting, the Members must make a new request under rule 35.

- b) in any other case
  - i) the meeting must be adjourned to a date not more than 21 days after the adjournment; and
  - ii) notice of the date, time and place to which the meeting is adjourned must be given at the meeting and confirmed by written notice given to all Members as soon as practicable after the meeting.
- 4) If a quorum is not present within 30 minutes after the time to which a General Meeting has been adjourned under subrule (3)(b), the Members present at the meeting (if not fewer than 3) may proceed with the business of the meeting as if a quorum were present.

## 40 Adjournment of General Meeting

- The Chairperson of a General Meeting at which a quorum is present may, with the consent of a majority of Members present at the meeting, adjourn the meeting to another time at the same place or at another place.
- 2) Without limiting subrule (1), a meeting may be adjourned
  - a) if there is insufficient time to deal with the business at hand; or
  - b) to give the Members more time to consider an item of business.

#### **Example**

The Members may wish to have more time to examine the financial statements submitted by the Committee at an annual General Meeting.

- 3) No business may be conducted on the resumption of an adjourned meeting other than the business that remained unfinished when the meeting was adjourned.
- 4) Notice of the adjournment of a meeting under this rule is not required unless the meeting is adjourned for 14 days or more, in which case notice of the meeting must be given in accordance with Rule 33.

## 41 Voting at General Meeting

- 1) On any question arising at a General Meeting
  - a) subject to subrule (3), each Member who is entitled to vote has one vote; and
  - b) Members may vote personally or by proxy; and
  - c) except in the case of a Special Resolution, the question must be decided on a majority of votes.
- 2) If votes are divided equally on a question, the Chairperson of the meeting has a second or casting vote.
- 3) If the question is whether or not to confirm the minutes of a previous meeting, only Members who were present at that meeting may vote.
- 4) This rule does not apply to a vote at a disciplinary appeal meeting conducted under Rule 27.

## 42 Special resolutions

1) A Special Resolution is passed if not less than three quarters of the Members voting at a General Meeting (whether in person or by proxy) vote in favour of the resolution.

#### Note

- 2) In addition to certain matters specified in the Act, a Special Resolution is required
  - a) to remove a Committee Member from office;
  - b) to alter these Rules, including changing the name or any of the purposes of the Association.

## 43 Determining whether resolution carried

- 1) Subject to subsection (2), the Chairperson of a General Meeting may, on the basis of a show of hands, declare that a resolution has been
  - a) carried; or
  - b) carried unanimously; or
  - c) carried by a particular majority; or
  - d) lost-

and an entry to that effect in the minutes of the meeting is conclusive proof of that fact.

- 2) If a poll (where votes are cast in writing) is demanded by three or more Members on any question
  - a) the poll must be taken at the meeting in the manner determined by the Chairperson of the meeting; and
  - b) the Chairperson must declare the result of the resolution on the basis of the poll.
- 3) A poll demanded on the election of the Chairperson or on a question of an adjournment must be taken immediately.
- 4) A poll demanded on any other question must be taken before the close of the meeting at a time determined by the Chairperson.

## 44 Minutes of General Meeting

- 1) The Committee must ensure that minutes are taken and kept of each General Meeting.
- 2) The minutes must record the business considered at the meeting, any resolution on which a vote is taken and the result of the vote.
- 3) In addition, the minutes of each annual General Meeting must include
  - a) the names of the Members attending the meeting; and
  - b) proxy forms given to the Chairperson of the meeting under rule 37(6); and
  - c) the financial statements submitted to the Members in accordance with rule 33(4)(b)(ii); and
  - d) the certificate signed by two Committee Members certifying that the financial statements give a true and fair view of the financial position and performance of the Association; and
  - e) any audited accounts and auditor's report or report of a review accompanying the financial statements that are required under the Act.

# PART 5—COMMITTEE AND STATE COUNCIL

## **Division 1—State Council**

## 45 Role and Powers

- 1) The governing body of the Association is a council called the State Council.
- 2) The State Council will provide strategic guidance and direction to the Committee regarding the affairs of the Association.

## 46 Composition of State Council

- 1) The State Council consists of
  - a) a delegate of each Affiliated Club; and
  - b) the Committee.
- 2) Each Affiliated Club must appoint a delegate to the State Council in accordance with the procedure for appointing delegates.
- 3) The procedure for appointing delegates must be determined at a General Meeting of the Association.
- 4) If a procedure for appointing delegates has not been determined under Rule 46(3), then the Affiliated Club may determine how it appoints a delegate.
- 5) A member of the Committee may also be a delegate to the State Council.
- 6) Committee members may not vote unless they are also a delegate to the State Council or they are the Chairperson casting a deciding vote in accordance with Rule 54(4).
- 7) The chairs of any subcommittees formed by the Association may be invited to attend the State Council, but may not vote.

## 47 Meetings of State Council

- 1) The State Council must meet at least 3 times in each year at the dates, times and places determined by the Committee.
- 2) A meeting of the State Council will be chaired by the President of the Association.

## 48 Notice of meetings

- 1) Notice of each State Council meeting must be given to each Affiliated Club no later than 14 days before the date of the meeting.
- 2) Notice may be given of more than one State Council meeting at the same time.
- 3) The notice must state the date, time and place of the meeting.
- 4) The only business that may be conducted at the meeting is the business for which the meeting is convened.

## 49 Special Meetings of State Council held at request of Affiliated Clubs

- 1) The Committee must convene a special State Council meeting if a request to do so is made in accordance with subrule (2) by at least 4 Affiliated Clubs.
- 2) A request for a special State Council meeting must
  - a) be in writing; and

- b) state the business to be considered at the meeting and any resolutions to be proposed; and
- c) include the names and signatures of delegates from at least 4 Affiliated Clubs; and
- d) be given to the Secretary.
- 3) If the Committee does not convene a special State Council meeting within one month after the date on which the request is made, the Affiliated Clubs making the request (or any of them) may convene the special State Council meeting.
- 4) A special State Council meeting convened by Affiliated Clubs under subrule (3)
  - a) Must be held within 3 months after the date on which the original request was made; and
  - b) May only consider the business stated in that request.
- 5) The Association must reimburse all reasonable expenses incurred by the Members convening a special State Council meeting under subrule (3).

## 50 Urgent meetings

- In cases of urgency, a meeting can be held without notice being given in accordance with rule Error! Reference source not found. provided that as much notice as practicable is given to each Affiliated Club by the quickest means practicable.
- 2) Any resolution made at the meeting must be passed by an Absolute Majority of the State Council.
- 3) The only business that may be conducted at an urgent meeting is the business for which the meeting is convened.

## 51 Procedure and order of business

- 1) The procedure to be followed at a meeting of a State Council must be determined from time to time by the State Council.
- 2) The order of business may be determined by the Members present at the meeting.

## 52 Use of technology

- A State Council Member who is not physically present at a State Council meeting may participate in the meeting by the use of technology that allows that State Council Member and the State Council Members present at the meeting to clearly and simultaneously communicate with each other.
- 2) For the purposes of this Rule, a State Council Member participating in a State Council meeting as permitted under subrule (1) is taken to be present at the meeting and, if the State Council Member votes at the meeting, is taken to have voted in person.

## 53 Quorum

- 1) No business may be conducted at a State Council meeting unless a quorum is present.
- 2) The quorum for a State Council meeting is the presence (in person or as allowed under rule 52) of one third of the number of Affiliated Clubs and a minimum of 5 Members in total excluding the Committee except for Committee members who are also delegates.
- 3) If a quorum is not present within 30 minutes after the notified commencement time of a Committee meeting
  - a) in the case of a special meeting—the meeting lapses;
  - b) in any other case—the meeting must be adjourned to a date no later than 14 days after the adjournment and notice of the time, date and place to which the meeting is adjourned must be given in accordance with rule 48.

## 54 Voting

- 1) On any question arising at a State Council meeting, each State Council Member present at the meeting has one vote.
- 2) A motion is carried if a majority of State Council Members present at the meeting vote in favour of the motion.
- 3) Subrule (2) does not apply to any motion or question which is required by these Rules to be passed by an Absolute Majority of the State Council.
- 4) If votes are divided equally on a question, the Chairperson of the meeting has a second or casting vote.
- 5) Voting by proxy is not permitted.

## 55 Conflict of interest

- 1) A State Council Member who has a material personal interest in a matter being considered at a State Council meeting must disclose the nature and extent of that interest to the State Council.
- 2) The State Council (excluding the State Council Member who has declared a material personal interest) must determine:
  - a) if the matter constitutes a genuine conflict of interest; and
  - b) the appropriate procedure for managing the declared conflict.
- 3) The State Council may determine that the relevant State Council Member
  - a) must not be present while the matter is being considered at the meeting; and
  - b) must not vote on the matter.
- 2) This rule does not apply to a material personal interest
  - a) that exists only because the State Council Member belongs to a class of persons for whose benefit the Association is established; or
  - b) that the State Council Member has in common with all, or a substantial proportion of, the Members of the Association.

## 56 Minutes of meeting

- 1) The Committee must ensure that minutes are taken and kept of each State Council meeting.
- 2) The minutes must record the following
  - a) the names of the Members in attendance at the meeting;
  - b) the business considered at the meeting;
  - c) any resolution on which a vote is taken and the result of the vote;
  - d) any material personal interest disclosed under rule 55.

## **Division 2—Powers of Committee**

### 57 Role and powers

- 1) The business of the Association must be managed by or under the direction of a Committee.
- 2) The Committee may exercise all the powers of the Association except those powers that these Rules or the Act require to be exercised by General Meetings of the Members of the Association.
- 3) The Committee may
  - a) appoint and remove staff;
  - b) establish subcommittees consisting of Members with terms of reference it considers appropriate.
- 4) The Committee must not act contrary to a resolution of the State Council, unless that act would be in contravention of these Rules or the Act.

## 58 Delegation

- 1) The Committee may delegate to a Member of the Committee, a subcommittee or staff, any of its powers and functions other than
  - a) this power of delegation; or
  - b) a duty imposed on the Committee by the Act or any other law.
- 2) The delegation must be in writing and may be subject to the conditions and limitations the Committee considers appropriate.
- 3) The Committee may, in writing, revoke a delegation wholly or in part.

## Division 3—Composition of Committee and duties of Members

#### 59 Composition of Committee

- 4) The Committee consists of
  - a) a President; and
  - b) a Vice-President; and
  - c) a Secretary; and
  - d) a Treasurer; and
  - e) a VKR Registrar; and
  - f) Any other Ordinary Members elected under rule 69.

#### 60 General Duties

- 1) As soon as practicable after being elected or appointed to the Committee, each Committee Member must become familiar with these Rules and the Act.
- 2) The Committee is collectively responsible for ensuring that the Association complies with the Act and that individual Members of the Committee comply with these Rules.
- 3) Committee Members must exercise their powers and discharge their duties with reasonable care and diligence.
- 4) Committee Members must exercise their powers and discharge their duties
  - a) in good faith in the best interests of the Association; and

- b) for a proper purpose.
- 5) Committee Members and former Committee Members must not make improper use of
  - a) their position; or
  - b) information acquired by virtue of holding their position-

so as to gain an advantage for themselves or any other person or to cause detriment to the Association.

#### Note

See also Division 3 of Part 6 of the Act which sets out the general duties of the office holders of an incorporated association.

6) In addition to any duties imposed by these Rules, a Committee Member must perform any other duties imposed from time to time by resolution at a General Meeting.

## 61 President and Vice-President

- 1) Subject to subrule (2), the President or, in the President's absence, the Vice-President is the Chairperson for any General Meetings and for any Committee meetings.
- 2) If the President and the Vice-President are both absent, or are unable to preside, the Chairperson of the meeting must be
  - a) in the case of a General Meeting—a Member elected by the other Members present; or
  - b) in the case of a Committee meeting—a Committee Member elected by the other Committee Members present; or
  - c) in the case of a State Council Meeting—a Member elected by the other Members present.

#### 62 Secretary

1) The Secretary must perform any duty or function required under the Act to be performed by the secretary of an incorporated association.

#### Example

Under the Act, the secretary of an incorporated association is responsible for lodging documents of the association with the Registrar.

- 2) The Secretary must
  - a) keep custody of the common seal (if any) of the Association and, except for the financial records referred to in rule 87(3), all books, documents and securities of the Association in accordance with rules 86 and 90; and
  - b) subject to the Act and these Rules, provide Members with access to the register of Members, the minutes of General Meetings and other books and documents; and
  - c) perform any other duty or function imposed on the Secretary by these Rules.
- 3) The Secretary must give to the Registrar notice of his or her appointment within 14 days after the appointment.
- 4) The Secretary of the Association shall keep minutes of the resolutions and proceedings of each General Meeting in books provided for that purpose together with a record of the names of persons present.
- 5) Notwithstanding sub-clause 62.1 the Committee may appoint a competent person to perform the duties of the Secretary on behalf of the Association.

#### 63 Treasurer

- 1) The Treasurer must
  - a) receive all moneys paid to or received by the Association and issue receipts for those moneys in the name of the Association; and
  - b) ensure that all moneys received are paid into the account of the Association within 5 working days after receipt; and
  - c) make any payments authorised by the Committee or by a General Meeting of the Association from the Association's funds; and
  - d) ensure cheques are signed by at least 2 Committee Members.
- 2) The Treasurer must
  - a) ensure that the financial records of the Association are kept in accordance with the Act; and
  - b) coordinate the preparation of the financial statements of the Association and their certification by the Committee prior to their submission to the annual General Meeting of the Association.
- 3) The Treasurer must ensure that at least one other Committee Member has access to the accounts and financial records of the Association.
- 4) Notwithstanding sub-clause 63.2 the Committee may appoint a competent person or organisation to perform the duties of the Treasurer on behalf of the Association. The Treasurer, however, shall always be responsible for submitting the statement of accounts to the annual General Meeting is accordance with Section 71 (1) of the Act.

## 64 VKR Registrar

- 1) The VKR Registrar must
  - a) maintain the register of Members in accordance with Rule 21; and
  - b) consider any applications for Membership and approve or reject in accordance with these Rules; and
  - c) perform any other duty or function imposed on the VKR Registrar by these Rules.
- 2) If the position of VKR Registrar becomes vacant then all duties under this rule will become the responsibility of the Secretary.

## Division 4—Election of Committee Members and tenure of office

## 65 Who is eligible to be a Committee Member

- 1) A Member is eligible to be elected or appointed as a Committee Member if the Member
  - a) is 18 years or over; and
  - b) is entitled to vote at a General Meeting.

#### 66 Positions to be declared vacant

- 1) This rule applies to -
  - a) the first annual General Meeting of the Association after its incorporation; or
  - b) any subsequent annual General Meeting of the Association, after the annual report and financial statements of the Association have been received.

2) The Chairperson of the meeting must declare all positions on the Committee vacant and hold elections for those positions in accordance with rules 67 to 70.

## 67 Nominations

- 1) Prior to the election of each position, the Chairperson of the meeting must call for nominations to fill that position.
- 2) An eligible Member of the Association:
  - a) May nominate themselves; or
  - b) May be nominated by another Member of the Association with the nominee's consent.
- 3) Nominations of candidates for election as officers of the Association or as ordinary Members of the Committee shall
  - a) Be made in writing, signed by two Members of the Association and record the written consent of the candidate; and
  - b) Be delivered to the Secretary of the Association not less than 7 days before the date fixed for the holding of the annual General Meeting.
- 4) A Member who is nominated for a position and fails to be elected to that position may be nominated for any other position for which an election is yet to be held.

## 68 Election of President etc.

- 1) At the annual General Meeting, separate elections must be held for each of the following positions
  - a) President;
  - b) Vice-President;
  - c) Secretary;
  - d) Treasurer;
  - e) VKR Registrar.
- 2) If only one Member is nominated for the position, the Chairperson of the meeting must declare the Member elected to the position.
- 3) If more than one Member is nominated, a ballot must be held in accordance with rule 70.
- 4) On his or her election, the new President may take over as Chairperson of the meeting.

#### 69 Election of ordinary Members

- 1) The annual general meeting must by resolution decide the number of ordinary members of the Committee (if any) it wishes to hold office for the next year.
- 2) A single election may be held to fill all of those positions.
- 3) If the number of Members nominated for the position of ordinary Committee Member is fewer than or equal to the number to be elected, the Chairperson of the meeting must declare each of those Members to be elected to the position.
- 4) If the number of Members nominated exceeds the number to be elected, a ballot must be held in accordance with rule 58.
- 5) In the event of a casual vacancy occurring in the office of an ordinary Member of the Committee, the Committee may appoint a Member of the Association to fill the vacancy and the Member so appointed shall hold office, subject to these Rules, until the conclusion of the next annual General Meeting following the date of the appointment.

## 70 Ballot

- 1) If a ballot is required for the election of a position, the Chairperson of the meeting must appoint a Member to act as returning officer to conduct the ballot.
- 2) The returning officer must not be a Member nominated for the position.
- 3) Before the ballot is taken, each candidate may make a short speech in support of his or her election.
- 4) The election must be by secret ballot.
- 5) The election may be conducted in person or via a suitable online voting system that allows for the ballot to be conducted in accordance with these Rules.
- 6) In the case of an in person ballot, the returning officer must give a blank piece of paper to
  - a) each Member present in person; and
  - b) each proxy appointed by a Member.

#### Example

If a Member has been appointed the proxy of 5 other Members, the Member must be given 6 ballot papers—one for the Member and one each for the other Members.

- 7) In the case of an online ballot, the returning officer must provide secure access to an online ballot system to each Member present at the online meeting and that enables a Member to cast a proxy vote as required.
- 8) If the ballot is for a single position, the voter must write on the ballot paper, or select via the online ballot system, the name of the candidate for whom they wish to vote.
- 9) If the ballot is for more than one position
  - a) the voter must write on the ballot paper, or select via the online ballot system, the name of each candidate for whom they wish to vote;
  - b) the voter must not write, or select via the online ballot system, the names of more candidates than the number to be elected.
- 10) Ballot papers, or online submissions, that do not comply with subrule (9)(b) are not to be counted.
- 11) Each ballot paper, or online submission, on which the name of a candidate has been written, or selected, counts as one vote for that candidate.
- 12) The returning officer must declare elected the candidate or, in the case of an election for more than one position, the candidates who received the most votes.
- 13) If the returning officer is unable to declare the result of an election under subrule (12) because 2 or more candidates received the same number of votes, the returning officer must
  - a) conduct a further election for the position in accordance with subrules (4) to (12) to decide which of those candidates is to be elected; or
  - b) with the agreement of those candidates, decide by lot which of them is to be elected.

#### **Examples**

The choice of candidate may be decided by the toss of a coin, drawing straws or drawing a name out of a hat.

## 71 Term of office

- 1) Subject to subrule (3) and rule 72, a Committee Member holds office until the positions of the Committee are declared vacant at the next annual General Meeting.
- 2) A Committee Member may be re-elected.

- 3) A General Meeting of the Association may
  - a) by Special Resolution remove a Committee Member from office; and
  - b) elect an eligible Member of the Association to fill the vacant position in accordance with this Division.
- 4) A Member who is the subject of a proposed Special Resolution under subrule (3)(a) may make representations in writing to the Secretary or President of the Association (not exceeding a reasonable length) and may request that the representations be provided to the Members of the Association.
- 5) The Secretary or the President may give a copy of the representations to each Member of the Association or, if they are not so given, the Member may require that they be read out at the meeting at which the Special Resolution is to be proposed.

## 72 Vacation of office

- 1) A Committee Member may resign from the Committee by written notice addressed to the Committee.
- 2) A person ceases to be a Committee Member if he or she
  - a) ceases to be a Member of the Association; or
  - b) fails to attend 3 consecutive Committee meetings (other than special or urgent Committee meetings) without leave of absence under rule 83; or
  - c) otherwise ceases to be a Committee Member by operation of section 78 of the Act.

#### Note

A Committee Member may not hold the office of secretary if they do not reside in Australia.

#### 73 Filling casual vacancies

- 1) The Committee may appoint an eligible Member of the Association to fill a position on the Committee that
  - a) has become vacant under rule 72; or
  - b) was not filled by election at the last annual General Meeting.
- 2) If the position of Secretary becomes vacant, the Committee must appoint a Member to the position within 14 days after the vacancy arises.
- 3) Rule 71 applies to any Committee Member appointed by the Committee under subrule (1) or (2).
- 4) The Committee may continue to act despite any vacancy in its Membership.

## **Division 5—Meetings of Committee**

## 74 Meetings of Committee

- 1) The Committee must meet at least 3 times in each year at the dates, times and places determined by the Committee.
- 2) The date, time and place of the first Committee meeting must be determined by the Members of the Committee as soon as practicable after the annual General Meeting of the Association at which the Members of the Committee were elected.
- 3) Special Committee meetings may be convened by the President or by any 4 Members of the Committee.

## 75 Notice of meetings

- 1) Notice of each Committee meeting must be given to each Committee Member no later than 7 days before the date of the meeting.
- 2) Notice may be given of more than one Committee meeting at the same time.
- 3) The notice must state the date, time and place of the meeting.
- 4) If a special Committee meeting is convened, the notice must include the general nature of the business to be conducted.
- 5) The only business that may be conducted at the meeting is the business for which the meeting is convened.

## 76 Urgent meetings

- In cases of urgency, a meeting can be held without notice being given in accordance with rule 75
  provided that as much notice as practicable is given to each Committee Member by the quickest means
  practicable.
- 2) Any resolution made at the meeting must be passed by an Absolute Majority of the Committee.
- 3) The only business that may be conducted at an urgent meeting is the business for which the meeting is convened.

#### 77 Procedure and order of business

- 1) The procedure to be followed at a meeting of a Committee must be determined from time to time by the Committee.
- 2) The order of business may be determined by the Members present at the meeting.

#### 78 Use of technology

- 1) A Committee Member who is not physically present at a Committee meeting may participate in the meeting by the use of technology that allows that Committee Member and the Committee Members present at the meeting to clearly and simultaneously communicate with each other.
- 3) For the purposes of this Part, a Committee Member participating in a Committee meeting as permitted under subrule (1) is taken to be present at the meeting and, if the Member votes at the meeting, is taken to have voted in person.

#### 79 Quorum

- 1) No business may be conducted at a Committee meeting unless a quorum is present.
- 2) The quorum for a Committee meeting is the presence (in person or as allowed under rule 78) of 3 Committee Members.
- 3) If a quorum is not present within 30 minutes after the notified commencement time of a Committee meeting
  - a) in the case of a special meeting—the meeting lapses;
  - b) in any other case—the meeting must be adjourned to a date no later than 14 days after the adjournment and notice of the time, date and place to which the meeting is adjourned must be given in accordance with rule 75.

## 80 Voting

- 1) On any question arising at a Committee meeting, each Committee Member present at the meeting has one vote.
- 2) A motion is carried if a majority of Committee Members present at the meeting vote in favour of the motion.
- 3) Subrule (2) does not apply to any motion or question which is required by these Rules to be passed by an Absolute Majority of the Committee.
- 4) If votes are divided equally on a question, the Chairperson of the meeting has a second or casting vote.
- 5) Voting by proxy is not permitted.

## 81 Conflict of interest

- 1) A Committee Member who has a material personal interest in a matter being considered at a Committee meeting must disclose the nature and extent of that interest to the Committee.
- 2) The Committee (excluding the Committee Member who has declared a material personal interest) must determine:
  - a) if the matter constitutes a genuine conflict of interest; and
  - b) the appropriate procedure for managing the declared conflict.
- 3) The Committee may determine that the relevant Committee Member
  - a) must not be present while the matter is being considered at the meeting; and
  - b) must not vote on the matter.

#### Note

Under section 81(3) of the Act, if there are insufficient Committee Members to form a quorum because a Member who has a material personal interest is disqualified from voting on a matter, a General Meeting may be called to deal with the matter.

- 4) This rule does not apply to a material personal interest
  - a) that exists only because the Member belongs to a class of persons for whose benefit the Association is established; or
  - b) that the Member has in common with all, or a substantial proportion of, the Members of the Association.

#### 82 Minutes of meeting

- 1) The Committee must ensure that minutes are taken and kept of each Committee meeting.
- 2) The minutes must record the following
  - a) the names of the Members in attendance at the meeting;
  - b) the business considered at the meeting;
  - c) any resolution on which a vote is taken and the result of the vote;
  - d) any material personal interest disclosed under rule 81.

#### 83 Leave of absence

1) The Committee may grant a Committee Member leave of absence from Committee meetings for a period not exceeding 3 months.

2) The Committee must not grant leave of absence retrospectively unless it is satisfied that it was not feasible for the Committee Member to seek the leave in advance.

## **Division 6—Technical Subcommittees**

#### 84 Technical Subcommittees

- 1) The Committee may establish technical subcommittees, including (but not limited to):
  - a) Kendo Technical Subcommittee; and
  - b) Iaido Technical Subcommittee; and
  - c) Jodo Technical Subcommittee.
- 2) Each technical subcommittee is to comprise Members of the Association appointed for their seniority, expertise and experience.
- 3) The State Council is required to approve the terms of reference for each technical subcommittee, the process for appointing Members and the term of Membership.

# PART 6—FINANCIAL MATTERS

## 85 Source of funds

1) The funds of the Association may be derived from joining fees, annual subscriptions, donations, fundraising activities, grants, interest and any other sources approved by the Committee.

## 86 Management of funds

- 1) The Association must open an account with a financial institution from which all expenditure of the Association is made and into which all of the Association's revenue is deposited.
- 2) Subject to any restrictions imposed by a General Meeting of the Association, the Committee may approve expenditure on behalf of the Association.
- 3) The Committee may authorise the Treasurer to expend funds on behalf of the Association (including by electronic funds transfer) up to a specified limit without requiring approval from the Committee for each item on which the funds are expended.
- 4) All cheques, drafts, bills of exchange, promissory notes and other negotiable instruments must be signed by 2 Committee Members.
- 5) All funds of the Association must be deposited into the financial account of the Association no later than 5 working days after receipt.
- 6) With the approval of the Committee, the Treasurer may maintain a cash float provided that all money paid from or paid into the float is accurately recorded at the time of the transaction.

## 87 Financial records

- 1) The Association must keep financial records that
  - a) correctly record and explain its transactions, financial position and performance; and
  - b) enable financial statements to be prepared as required by the Act.
- 2) The Association must retain the financial records for 7 years after the transactions covered by the records are completed.
- 3) The Treasurer must keep in his or her custody, or under his or her control
  - a) the financial records for the current Financial Year; and
  - b) any other financial records as authorised by the Committee.

#### 88 Financial statements

- 1) For each Financial Year, the Committee must ensure that the requirements under the Act relating to the financial statements of the Association are met.
- 2) Without limiting subrule (1), those requirements include
  - a) the preparation of the financial statements;
  - b) if required, the review or auditing of the financial statements;
  - c) the certification of the financial statements by the Committee;
  - d) the submission of the financial statements to the annual General Meeting of the Association; and
  - e) the lodgement with the Registrar of the financial statements and accompanying reports, certificates, statements and fee.

## 89 Appointment of Auditor

- 1) The Committee must appoint a suitably qualified and certified auditor to complete an audit of the Association's financial statements to be presented at the next Annual General Meeting.
- 2) The auditor must be appointed by such time to enable the auditor's report to be presented with the relevant financial statements at the next Annual General Meeting.
- 3) The auditor selected by the Committee must:
  - a) be approved by the State Council; and
  - b) hold a current practising certificate issued by either CPA Australia, the Institute of Chartered Accountants in Australia or Institute of Public Accountants; or
  - c) be any other suitably qualified person approved by the Registrar of Incorporated Associations for this purpose, such as a Member of the Association of Taxation and Management Accountants holding a current practising certificate.

# PART 7—GENERAL MATTERS

#### 90 Common seal

- 1) The Association may have a common seal.
- 2) If the Association has a common seal
  - a) the name of the Association must appear in legible characters on the common seal;
  - b) a document may only be sealed with the common seal by the authority of the Committee and the sealing must be witnessed by the signatures of two Committee Members;
  - c) the common seal must be kept in the custody of the Secretary.

## 91 Registered address

- 1) The registered address of the Association is
  - a) the address determined from time to time by resolution of the Committee; or
  - b) if the Committee has not determined an address to be the registered address—the postal address of the Secretary.

## 92 Notice requirements

- 1) Any notice required to be given to a Member or a Committee Member under these Rules may be given
  - a) by handing the notice to the Member personally; or
  - b) by sending it by post to the Member at the address recorded for the Member on the register of Members; or
  - c) by email or facsimile transmission.
- 2) Subrule (1) does not apply to notice given under rule 76.
- 3) Any notice required to be given to the Association or the Committee may be given
  - a) by handing the notice to a Member of the Committee; or
  - b) by sending the notice by post to the registered address; or
  - c) by leaving the notice at the registered address; or
  - d) if the Committee determines that it is appropriate in the circumstances-
  - e) by email to the email address of the Association or the Secretary; or
  - f) by facsimile transmission to the facsimile number of the Association.

## 93 Custody and inspection of books and records

- 1) Members may on request inspect free of charge
  - a) the register of Members;
  - b) the minutes of General Meetings;
  - c) subject to subrule (2), the financial records, books, securities and any other relevant document of the Association, including minutes of Committee meetings.

#### Note

See note following rule 21 for details of access to the register of Members.

- 2) The Committee may refuse to permit a Member to inspect records of the Association that relate to confidential, personal, employment, commercial or legal matters or where to do so may be prejudicial to the interests of the Association.
- 3) The Committee must on request make copies of these rules available to Members and applicants for Membership free of charge.
- 4) Subject to subrule (2), a Member may make a copy of any of the other records of the Association referred to in this rule and the Association may charge a reasonable fee for provision of a copy of such a record.
- 5) For purposes of this rule-

*relevant documents* means the records and other documents, however compiled, recorded or stored, that relate to the incorporation and management of the Association and includes the following—

- a) its Membership records;
- b) its financial statements;
- c) its financial records;
- d) records and documents relating to transactions, dealings, business or property of the Association.

## 94 Winding up and cancellation

- 1) The Association may be wound up voluntarily by Special Resolution.
- In the event of the winding up or the cancellation of the incorporation of the Association, the surplus assets of the Association must not be distributed to any Members or former Members of the Association.
- 3) Subject to the Act and any court order made under section 133 of the Act, the surplus assets must be given to a body that has similar purposes to the Association and which is not carried on for the profit or gain of its individual Members.
- 4) The body to which the surplus assets are to be given must be decided by Special Resolution.

## 95 Alteration of Rules

1) These Rules may only be altered by Special Resolution of a General Meeting of the Association.

#### Note

An alteration of these Rules does not take effect unless or until it is approved by the Registrar. If these Rules (other than rule 1, 2 or 3) are altered, the Association is taken to have adopted its own rules, not the model rules.
