Player's Agreement, Waiver & Release:

- 1. I will abide by and ensure the player abides by the rules and regulations as set out by the Club.
- 2. I acknowledge that all the terms and conditions relating to Skate Australia membership also apply to the West Logan Hockey Club membership.
- 3. This waiver, release and discharge shall be and operate separately in favour of all persons, corporations and bodies involved or otherwise engaged in the promoting or staging of all events and functions carried out by the Club and the servants, agents, representatives and officers of any of them and includes but is not limited to the Club, Skate Queensland, Skate Australia, and other event sponsors and supporters.
- 4. I attest that the player, on whose behalf I am registering, is to the best of my knowledge physically fit for the rigours associated with playing inline hockey and confirm that all medical conditions that may impact on their participation in the sport or that of other players and officials have been declared.
- 5. I consent to my child receiving medical treatment which may be advisable in the event of illness or injuries suffered in the course of participation in inline hockey events and associated functions.
- 6. I understand that safety precautions undertaken by the Club officials or their designated delegates (such as setting of rules and actions to administer the rules) are a service to all participants but are not a guarantee of safety.
- 7. I agree to abide by the conditions as stated above and as directed by any official or volunteer involved in the staging of events and functions.
- 8. I agree to abide by and ensure the player abides by the Code of Conduct for Parents/Guardians and Players (see p2 & 3)
- 9. I agree to abide by and ensure the player abides by the Core Principles of Sport as set out by the Australian Sports Commission:
 - Fairness Operating within the spirit of the rules, never taking an unfair advantage and making informed and honourable decisions at all times.
 - Respect Recognising the contribution which people make to sport, treating them with dignity and consideration, as well as caring for the property and equipment they use.
 - Responsibility Taking responsibility for one's actions and being a positive role model at all times.
 - Safety Encouraging healthy and safe procedures, preventing and reporting dangerous behaviour, while demonstrating concern for others.



PLAYER'S CODE OF CONDUCT

- Play by the rules the rules of your Club and the laws of the game.
- Attend training sessions and matches at times advised by the Club. If unable, for a valid reason to do so, players will inform the Club as soon, as is practical.
- Act respectfully toward the officials and players of their own and opposing Clubs.
- Respect and follow the directions of coaching staff, match and club officials.
- Treat all players with respect, as you would want them to treat you.
- Act respectfully towards match officials at all times. Abusive language is unacceptable.
- Avoid individual or collective behaviour, which may reasonably be held by spectators to be offensive.
- Avoid all acts likely to incite spectators to violence or disorder.
- Make no detrimental statements in public (radio, television, print or electronic media) in respect to the performance of any match officials, players, or any policy decisions of the Club, Skate Queensland or Inline Hockey Queensland
- Abide by the By-Laws, (Rules & Regulations) and the Competition Rules of Inline Hockey Queensland
- Respect the facilities and equipment of their own and opposing Clubs.
- Do not use remarks based on race, religion, gender or ability as many such comments are politically incorrect and it is your coach, team-mates, Club and family that are let down with such remarks.

- Never publicly criticise referees, rather raise personal concerns with club officials in private.
