WestVic Hockey is a club affiliated with Hockey Victoria and draws on players from the broad western Victorian region, incorporating but not limited to, Hockey Ballarat and the associations of Grampians, Maryborough, Warrnambool, Glenelg, Portland and Wimmera.

The program is designed to provide representative hockey at a high level for players who qualify for Hockey Victoria's U16 Competitions.

WestVic Hockey is an incorporated organisation with an overall Program Coordinator, as well as Head Coach(es), Assistant Coach(es) and a Team Manager for each team.

Communication:

WestVic Hockey will communicate with players and parents through individual and team contact, phone and text, facebook, RevSport, email and conventional mail.

Parents and players are asked to consider the following when communicating with WestVic Hockey:

For matters relating to games, training and team specific issues

Contact: Coach or Team Manager

For matters relating to the program requirements, player agreements and any issue not related to games, training or team specific issues

Contact: Junior Coordinator

For matters that are of potential concern, dispute or sensitivity

Contact: Club President, Coach or Manager as determined by the parent

Players and parents are encouraged to communicate with Coaches, Managers or the Club President on issues that are relevant, as soon as they become apparent.

IMPORTANT

By signing this Agreement, the player accepts their responsibility to uphold the obligations outlined and prescribed within.

Should a player breach their obligations under this Agreement, they accept that their position within the program may be subject to review by the Club President and the Coach and/or Manager.

Period of Agreement

This Player Agreement is valid from:

EITHER the date it is signed by the player and ends at the 1 November 2023
OR the date it is signed by the player until it is terminated under the termination's conditions described.

TERMINATION OF THE AGREEMENT

This Agreement may be terminated prior to the end of the Period of the Agreement by:

- a) Mutual agreement between you and the Club President
- b) At any time, you fail to comply with any of your obligations in this Agreement or behave in a manner that brings the Sport or WestVic Hockey into disrepute.

Medical

Players will complete the included medical information form and agree to have this information released to the Coach and Manager of the squad they are selected for.

Private Medical Insurance

You acknowledge that WestVic Hockey strongly encourages its players to have their own Private Medical Insurance, including the provision for Extras Cover, relevant to sporting populations. Details of your medical insurance will be made available to the Manager of your team.

Player Fees

The Player Fees for the junior teams are as follows.

\$360 Full participation player

\$175 Goalkeepers Fee.

These fees assist with the following team costs:

- Travel with the team from Ballarat and return, to games in the home and away season where feasible
- Competition fees
- Umpiring fees
- Facility payments
- Alternate strip playing shirts – while players are able to purchase their own alternate strip shirt, WestVic maintains team sets available for loan as necessary
- Coaching fees

From time to time, there may be additional requirements for payment that relate to extra travel or entry to competitions other than the Hockey Victoria Winter competition.

The player fees must be paid prior to playing for WestVic Hockey.

Sponsorship

You acknowledge and will consider supporting the Program Sponsors whenever possible.

Sponsor for all Programs

Players will agree to comply with all reasonable directions of WestVic Hockey to assist in the promotion of its sponsors.

Promotion & Media

Players will allow WestVic Hockey to use your identity to promote WestVic Hockey in ways that support the promotion of the game and the program in the region.

Players will not appear or participate in, or permit their Identity to be used in any advertising, promotion or marketing activities related to their role as a WestVic Hockey player, without the prior consent of the Club President.

When taking part in any activity that could promote WestVic Hockey, players will wear appropriate WestVic uniform.

Your Obligations

For the Period of this Agreement you agree to:

1. Commit to attend all designated team training sessions and games
2. Contact the coach if you unable to attend a training session, game or other WestVic commitments
3. Train and keep yourself in the best possible physical condition to enable you to contribute to the squad to the best of your ability. Immediately inform your coach if you have an injury or illness which may affect your performance at training or matches.
4. Comply with all reasonable directions of the Coach, Manager and Club President
5. Compete within the spirit of fair play at all times, showing respect for your team, WestVic Personnel, umpires and other match officials, spectators and your opponents
6. Wear the designated uniform for games and when travelling as part of the team
7. Not consume, nor encourage the consumption of, drugs, stimulants or other substances with a view to modifying or altering your growth or performance as set out in the ASADA Anti-Doping By-Laws
8. Not consume, nor encourage the consumption, of alcohol or cigarettes whilst involved in any approved WestVic activity
9. Where possible travel with the team. Please discuss this with your Coach or Manager.
10. Pay all associated fees, levy's, uniform and match payments by the due date, or make arrangements for an agreed payment plan in consultation with the Treasurer.
11. Maintain up-to-date registration with Hockey Victoria, and show evidence of this to your Manager prior to the start of the season.
12. Ensure that you have a valid transfer if this is needed, prior to the start of the season.

WestVic Hockey's Obligations

For the Period of this Agreement, WestVic Hockey will:

1. Provide quality coaching and team management to ensure that the players have the opportunity to play in their respective divisions.
2. Provide and maintain an environment that is conducive to individual player and team development.
3. Liaise with players both formally and informally regarding their progress, strengths and weaknesses.
4. Speak with parents regarding the progress of their son/daughter at appropriate times throughout the season where necessary.
5. Oversee the operation of the program and ensure the teams meet the requirements of Hockey Victoria competition.
6. At all times provide a safe and enjoyable training environment.
7. Where at all possible provide bus transport for the teams travelling from Ballarat and return, to away fixtures as part of the home and away season.
8. At all times promote fair play, sportsmanship and humility as part of the WestVic Program.
9. Only disclose personal information, including medical information, only to appropriate persons and maintain confidentiality in relation to all other personal information.
